Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

The deadline for your agency to provide this information is **June 10, 2026**. As a starting point, I'm proposing a few readoption deadlines options for your consideration: **November 1, 2029 or January 1, 2030**. I am open to considering a different readoption deadline based on the needs of your agency.
