The following is submitted as required to Mr. Travis Wiggs, for rules under the Board of Agriculture whose periodic review reports were approved by the Rules Review Commission at the July 2025 meeting.

This timeline is a proposed readoption schedule for the above-mentioned rules. The dates noted on the timeline refer to a deadline, and not a specific date, as the meeting dates for the Commission for 2026 – 2028 have not yet been established. The timeline is based on previous meeting dates typical of the Commission's schedule, as well as built-in additional meetings should the proposed initial date be otherwise cancelled, etc.
