Anna,

Given that this ruleset is 104 rules, the Commission would like to try and fit them in a meeting where we don't already have a substantial number of rules. So we can do a January 1, 2030, but we would prefer if the agency aim for having them on the January 2030 meeting specifically. That would mean filing them between November 21st and December 20th, 2029. And the agency would have to adopt them within the 30 days before filing. The rules would then have a February 1, 2030, effective date at the earliest.

Does that plan work for you? If so, I will recommend a January 1, 2030, readoption deadline at the upcoming meeting. If that doesn't work, we can look at later possibilities in 2030.
