4 **HUNTING ON GAME LANDS**

5 (a) Safety Requirements. No person while hunting on any designated game land shall be under the influence of alcohol
6 or any narcotic drug, or fail to comply with restrictions enacted by the National Park Service regarding the use of the
7 Blue Ridge Parkway where it adjoins game lands listed in this Rule.

8 (b) Traffic Requirements. No person shall park a vehicle on game lands in such a manner as to block traffic or gates,
9 or otherwise prevent vehicles from using any roadway.

10 (c) Tree Stands. It is unlawful to erect or to occupy, for the purpose of hunting, any tree stand or platform attached
11 by nails, screws, bolts, or wire to a tree on any game land designated herein. This prohibition does not apply to lag-
12 screw steps or portable stands that are removed after use with no metal remaining in or attached to the tree.

13 (d) Time and Manner of Taking. Hunting is allowed on game lands only during the open season for game animals
14 and game birds, unless hunting is allowed by permit. Individual game lands or parts thereof may be closed to hunting
15 or limited to specific dates by this Chapter. Persons shall hunt only with weapons lawful for the open game animal or
16 game bird seasons. ~~On managed waterfowl impoundments, persons shall:~~

- 17 ~~(1) not enter the posted impoundment areas earlier than 4:00 a.m. on the permitted hunting dates;~~
18 ~~(2) not hunt after 1:00 p.m. on such hunting dates;~~
19 ~~(3) not set decoys out prior to 4:00 a.m.;~~
20 ~~(4) remove decoys by 3:00 p.m. each day; and~~
21 ~~(5) not operate any vessel or vehicle powered by an internal combustion engine.~~

22 (1) On managed waterfowl impoundments, persons shall:

- 23 (A) not enter the posted impoundment areas earlier than 4:00 a.m. on the permitted hunting
24 dates;
25 (B) not hunt after 1:00 p.m. on such hunting dates;
26 (C) not set decoys out prior to 4:00 a.m.;
27 (D) remove decoys by 3:00 p.m. each day; and
28 (E) not operate any vessel or vehicle powered by an internal combustion engine.

29 (2) On Sundays, the following shall be prohibited:

- 30 (A) hunting with a firearm between 9:30 AM and 12:30 PM;
31 (B) the use of a firearm to take deer that are run or chased by dogs;
32 (C) hunting with a firearm within 500 yards of a place of religious worship, as defined by G.S.
33 14-54.1(b), or any accessory structure thereof, and
34 (D) hunting migratory game birds.

35 On designated youth waterfowl days, youths may hunt on managed waterfowl impoundments from ½ hour before
36 sunrise to sunset. On designated veterans and military waterfowl days, veterans, as defined in 38 USC 101, and
37 members of the Armed Forces on active duty, including members of the National Guard and Reserves on active duty

1 other than for training, with valid credentials may hunt on game lands and impoundments not designated as permit-
2 only areas from ½ hour before sunrise to sunset. Restrictions ~~(1)~~, ~~(1)(A)~~, ~~(1)(C)~~, ~~(3)~~, and ~~(5)~~ ~~(1)(E)~~ in this Paragraph
3 shall apply. On waterfowl impoundments that have a posted "Scouting-only Zone," trapping during the trapping
4 season and waterfowl hunting on designated waterfowl hunting days are the only activities allowed on the portion of
5 the impoundment outside of the posted "Scouting-only Zone." ~~No person shall attempt to obscure the sex or age of~~
6 ~~any bird or animal taken by severing the head or any other part thereof, or possess any bird or animal that has been so~~
7 ~~mutilated. No person shall place, or cause to be placed on any game land, salt, grain, fruit, or other foods without prior~~
8 ~~written authorization of the Commission or its agent. A decision to grant or deny authorization shall be made based~~
9 ~~on the best management practices for the wildlife species in question. No person shall take or attempt to take any game~~
10 ~~birds or game animals attracted to such foods.~~

11 (e) Definitions:

- 12 (1) For purposes of this Section, "Dove Only Area" refers to a Game Land on which doves may be
13 taken and dove hunting is limited to Mondays, Wednesdays, Saturdays, Thanksgiving Day,
14 Christmas Day, and New Year's Days within the federally-announced season.
- 15 (2) For purposes of this Section, "Three Days per Week Area" refers to a Game Land on which any
16 game may be taken during the open seasons and hunting is limited to Mondays, Wednesdays,
17 Saturdays, Thanksgiving Day, Christmas Day, and New Year's Days, except for game lands in this
18 Rule that specifically allow hunting on Tuesdays, Thursday, and Fridays. Falconry may also be
19 practiced on Sundays. These "open days" also apply to either-sex deer hunting seasons listed under
20 each game land. Raccoon and opossum hunting may continue until 7:00 a.m. on Tuesdays, until
21 7:00 a.m. on Thursdays, and until midnight on Saturdays.
- 22 (3) For purposes of this Section, "Six Days per Week Area" refers to a Game Land on which any game
23 may be taken on the open days of Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday
24 during the open seasons.
- 25 (4) For purposes of this Section, "Seven Days per Week Area" refers to a Game Land on which game
26 may be taken during the open season on Mondays, Tuesdays, Wednesdays, Thursdays, Fridays,
27 Saturdays, and Sundays.
- 28 (5) For purposes of this Section, "Four Days per Week Area" refers to a Game Land on which any game
29 may be taken during the open seasons and hunting is limited to Tuesdays, Thursdays, Saturdays,
30 and Sundays. Raccoon and opossum hunting may continue until 7:00 a.m. on Wednesdays, 7:00
31 a.m. on Fridays, and 7:00 a.m. on Mondays.

32 (f) Hunting with Dogs on Game Lands. Deer shall not be taken with the use of dogs on game lands in counties or
33 parts of counties where taking deer with dogs is prohibited as described in 15A NCAC 10B .0109.

- 26 (6) The maximum period of consecutive overnight camping at any posted and designated camping
27 area is 14 days within any 30-day period.
