- 3. At the close of the 60-day comment period, the Board, Commission, or agency head must review all comments received, prepare a response for each public comment to put in the report, and make a final determination for each rule.
- 4. File the Excel report with initial designations and the accompanying form to oah.rules@oah.nc.gov

If your agency does not complete the process and submits a final report by September 20, 2025, all rules in the report will automatically expire at the meeting the following month. The agency's rules will be removed from the North Carolina Administrative Code. Further, G.S. 150B-21.3A requires the Rules Review Commission to report all rules that expired to the General Assembly's Joint Legislative Administrative Procedure Oversight Committee.
