Hi Travis,

After further discussion with DNCR management, I'd like to propose to move the readoption deadline for 07 NCAC O4M, 04N, 04O, 04P, 04Q, 04R, and 04T back to November 1, 2030. This additional time is necessary for DNCR because these rules are the most voluminous and complicated rules that DNCR has, many have not been updated since the 1980's, and they will likely take a significant amount of staff time and review to complete. Additionally, I've never done a fiscal note, so I'd like to build in some additional time for me to figure out how to do that, if they are necessary.

As requested, please see the proposed readoption timeline below for 07 NCAC 04M, 04N, 04O, 04P, 04Q, 04R, and 04T rules, based on this new proposed deadline. The dates noted on the timeline refer to a deadline, and not a specific date, as the meeting dates for the NC Historical Commission beyond 2025 have not yet been established. The timeline is based on previous meeting dates typical of the Commission's schedule.

Public Hearing: July 2030

Public Comment Period: June - September 2030

Commission meeting for final adoption: September 2030
