3 **19A NCAC 02D .0803 ADVERTISEMENT AND INVITATIONS FOR BIDS**

5 (a) All projects shall be advertised by the Department of Transportation in daily newspapers having general circulation
6 in throughout the state-State of North Carolina four weeks prior to the bid ~~opening~~-opening as set forth in G.S. 143-
7 129(b).~~[136-28.1 and 143-129.]~~

8 (b) On the date of advertisement, an invitation to bid shall be made available to interested parties on the Department's
9 ~~web site.~~website at connect.ncdot.gov/letting.

10 (c) The invitation to bid shall indicate state the contract identification number and description of the projects to be
11 ~~let, let to contract,~~ a general summary of the items and approximate quantities of work to be performed, and the time
12 and place for the public opening and reading of the bids received. Information concerning the cost and the availability
13 of bid documents shall also be provided in the invitation to bid.

14 (d) ~~Prospective~~ As a prerequisite for submitting a bid, prospective bidders who desire to bid on projects identified in
15 the invitation to bid shall sign up for the Interested Parties List for each project they intend to submit a bid on by
16 providing their firm name, a contact name, and contact information via the Department's website at
17 connect.ncdot.gov/letting. ~~purchase~~ ~~[be added to the Authorized Bidders List. The Authorized Bidder's List is~~
18 ~~composed of contractors that are prequalified.]~~Only prospective bidders that have prequalified status pursuant to [as
19 set forth in] Rule .0801 of this Section [that have also added themselves to] and who sign up for the Interested Parties
20 List will be eligible to bid.~~[found on the Department's website at connect.ncdot.gov/letting.]~~the project specific bid
21 documents ~~from the Department containing information necessary to submit the bid. Other interested parties may~~
22 ~~also purchase project specific bid documents from the Department. Documents may be purchased at cost from the~~
23 ~~Department.~~

24 ~~[(e) Authorized bidders shall sign up for the Interested Parties List to receive letting information by:~~
