In reviewing this Rule, the staff recommends the following changes be made:

Rules .0101, .1101, and .1102 reference a "Notice of Intent" form. In Rule .1102, you specifically require Evaluators to use this form.

It is my understanding that in 2023 amendments to G.S. 130A-336.2, the General Assembly (1) required the Board (rather than DHHS) to develop this NOI form and (2) removed required form information from the statute's language. These changes do not appear to be reflected in the Board's rules.

Further, it appears as if the Board has developed this NOI form (https://ncowcicb.info/wp-content/uploads/2025/02/NCOWCICB-NOI-to-Construct-7-2023.pdf), but I could not locate any rule(s) in Chapter 39 which describe the contents of the form.

G.S. 150B-2 (8a) defines the word "rule." It further sets forth items which do not meet the definition the term, including "A form, the contents or substantive requirements of which are prescribed by rule." In order to require a form, you must specify the form's contents and substantive requirements in a rule. So if the Board wants to continue to require and use its NOI form, you will need to make rule changes accordingly.

In reviewing this Rule, the staff recommends the following changes be made:

In the Chapter Title, the word "ON" appears before "CHAPTER 39". I assume this is a typo. Please remove.

Item (2), line 14: "N.C." can be removed before "General Statutes".

Item (3), line 16: Consider hyphenating the term "point of sale inspector." The authority statutes use "point-of-sale inspector." If made, the change should be applied in all of the rules under review, where applicable.

Also, consider defining this term if it is not already defined elsewhere. It appears as if only "contractor" and "private compliance inspector" are defined in \S 90A-71.

Item (3), line 17: Rule .0603 was repealed in 2021. Please update the reference/citation.

Item (4), line 20: Add the word "is" between "activities and" and "pre-approved".

Item (5): Is this part of the rule intended to capture what all needs to be included in an Evaluation and findings? If so, this requirement may be better placed in a different Rule, and could be written as something like, "Evaluation and findings shall include ..."

Also, based on my review, the terminology "evaluation and findings" does not appear to be used anywhere else in Chapter 39 of your rules. Does it need to be defined at all? If you do want to keep the definition here, please remove "at a minimum" and list out the complete requirements to meet the definition.

Item (6): "North Carolina" can be removed before "General Statutes."

Item (7): A review of GS 130A-336.2(b) indicates that the statute does not specify what information needs to be included on the Notice form. Is there another statute, or rule,

that describes the information required in a Notice of Intent form? Please also see my General Comment on page 3 regarding the NOI form.

Items (13) and (14): These are out of order. Please incorporate these new definitions into the Rule's list numerically based on alphabetical order.

Item (13): I believe this term is defined at 90A-71(10), not 90A-71(8). Please update if that's correct.

Item (14): Insert the word "a" before "class".

Do your rules further define these certification standards for Evaluators? What rights does the certification provide to the Evaluator?

In the Section Title, a comma should be inserted after "PRIVATE COMPLIANCE INSPECTORS".

- (a)(1)(I): Update to "contractor or point-of-sale inspector;".
- (a)(1)(J): Should this include, "if applicable"? This information would not be necessary if the applicant was a point-of-sale inspector.
- (a)(1)(L): Consider pointing to the Fee Rule here for clarity. This could be written as, "Required certification fee as specified in Rule .0301 of this Chapter;".
- (a)(1)(P): Which experience requirements? The ones set forth in G.S. 90A-77? You may want to reference the statute here so that it is clear.
- (a)(1)(Q): Remove "(ies)" and "(s)". Also, you can just state "12 months" in the rule instead of "twelve (12) months".
- (a)(1)(S): "Applicant signature" is already required under (a)(1)(N). This appears to be redundant. Please delete if you agree.
- (a)(2)(I) and (a)(3)(I): Same comment as above regarding specification of fees. Also, in (a)(3)(I), it should be "Required," not "Require."
- (a)(2)(J): Remove "(ies)" and "(s)". Also, you can just state "12 months" in the rule instead of "twelve (12) months".
- (a)(2)(N): Is this 5-year experience requirement tied to a statutory requirement? I did not see anything in 90A-77 or 130A-336.2 that mentioned this.

- (a)(3)(J): Remove "(ies)" and "(s)". Also, you can just state "12 months" in the rule instead of "twelve (12) months".
- (a)(3)(L): What does "verification" mean in this context? How would an applicant verify their experience? Be specific, if possible.
- (b)(6): Same comment as above regarding specification of fees.
- (b)(8): What is an "LSS license"?
- (d): I would suggest clarifying by stating, "Upon approval of an **initial** application ..." I assume this requirement is not meant to apply to renewal applications.
- For (e), when does this apply? Applicants are already required to submit this information as part of the application. Would the Board then ask for this again around the time of examination? It is not clear. Also, what would constitute "verification"?
- (f): Which "Rules and statutes"? Be specific, if possible.
