- Current -July 1, 2026 Evaluate existing policies and amend to serve as a foundation for our rules
- July 1, 2026-Notify state office of budget regarding proposed changes so that governor's recommended budget for 2027 can effectuate the changes that need to occur
- July 1, 2026 October 2027 write rules to comply with periodic review process
- **November-December 2027** Seek approval from NC Department of Health & Human Services Secretary for proposed rule amendment approvals
- **January 2028** Notice sent to state register, notice of intent to make rules posted on agency and commission websites
- **February & March 2028** Public comment period, public hearing and notice in state register required by state law
- April 2028 submit the rules for review by the Rules Review Commission to determine if the Commission counsel will recommend approval
- May 2028 appear before the NC Rules Review Commission to have them approve rules
- June 1, 2028 effective earliest date
