- Current -July 1, 2026 -Evaluate existing policies and amend to serve as a foundation for our rules
- **July 1, 2026**-Notify state office of budget management (OBSM) regarding proposed changes so that governor's recommended budget for 2027 can effectuate the changes that need to occur
- July 1, 2026 October 2027 write rules to comply with periodic review process
- **November 2027** Seek approval from NC Department of Health & Human Services Secretary for proposed rule amendment approvals
- December 2027 Notice sent to state register, notice of intent to make rules posted on agency and commission websites

- Late Jan- March 2028 Public comment period, public hearing and notice in state register required by state law
- April 2028 Submit rules to agency for approval
- May 2028 submit the rules for review by the Rules Review Commission to determine if the Commission counsel will recommend approval
- June 2028 appear before the NC Rules Review Commission to have them approve rules
- August 1, 2028 effective earliest date/readoption date (Note, the agency would submit the rules to RRC prior to July 1, 2028, with submission being in June 2028, and as requested in your email below, but is asking the effective date (readoption date) to be the same as the other rules located in 10A NCAC 06 since they deal with the same issue. However, we would be before RRC prior to July 1, 2028, as requested below.)

The deadline for your agency to provide this information is **October 10, 2025**. As a starting point, I would recommend a **July 1, 2028**, readoption deadline, but I am open to considering a different recommendation based on the needs of your agency.
