Thanks for forwarding those additional emails. I believe they resolve the issue.

I have completed my review of your agency's periodic review reports and I have attached the reports I plan to recommend that the Commission adopt. The RRC will formally review these reports at its meeting on Thursday, January 30, 2025, at 10:00 a.m. The meeting will be a hybrid of in-person and WebEx attendance, and an invite should be sent to you as we get close to the meeting, or you are welcome to attend in person. If there are any other representatives from your agency who want to attend virtually, let me know prior to the meeting, and we will get invites out to them as well.

To summarize the situation with the anonymous comment (and please correct me if this does not match your understanding): On April 30th the codifier received an anonymous comment that one of the report for 13A was not posted on your website. The codifier looked at your website and took a screenshot of where she expected the report to be, but it was not there. You informed me that the website the codifier looked at was not where the report was posted, and showed me a different website where the reports are posted (<https://info.ncdhhs.gov/dhsr/rules/hb74/index.asp>). That site has some other reports currently posted, but the 13A is no longer there since the time for comment had elapsed several months ago. You also showed me email exchanges with the former rulemaking coordinator requesting that the report at issue be posted on that site in March of last year, and confirmation from IT staff confirming that they posted it. It is my opinion that this is sufficient to address any possible issue raised by the anonymous comment, and I plan to advise the RRC that there is no need to take action on the anonymous comment. Note that it is also my opinion that the anonymous comment, while it might qualify as a public comment in everyday speech, does not qualify as a public comment under the definition in G.S. 150B 21.3A(a)(5). Therefore it is not reflected in my recommended reports.
