This is the timeline for the readoption of 10A NCAC 14A:

May 2026 – August 2027 - Work with advisory committees, working groups of NC Medical Care Commission and stakeholders to amend rules, finalize amendments

August 2027 – August 2028 – work with OSBM to complete and get fiscal note approved

September 2028 – October 2028 – get DHSR legal and budget approval

October – November 2028 – get Secretary Debra Farrington approval

November 2028 – MCC approval at annual meeting to publish rules in Register and start readoption

December 2028 – submit rules to OAH to be published in NC Register

January 2029 – March 2029 – Rules published in NC Register, posted on DHSR rule action page, Notice to Interested Parties sent, 60 day comment period and any comments on rules discussed

March 2029 – get approval from Sec. Debra Farrington to go to RRC

April 2029 – rules approved at annual MCC meeting to go to RRC for readoption

May 2029 – submit rules to RRC

June 2029 – rules approved at RRC

consultation with the agency, and this email serves as the RRC's request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

The deadline for your agency to provide this information is **June 4, 2026**. As a starting point, I'm proposing a few readoption deadlines options for your consideration: **July 1, 2029 or November 1, 2029**. I am open to considering a different readoption deadline based on the needs of your agency.
