Hi Seth.

After checking emails, it appears these rules were not addressed back in June but readoption deadlines were set for 3 other chapters that our agency were discussing simultaneously, those being 11 NCAC 18, 20 and 21.

At this time, we would like to accept the previously proposed readoption deadline of July 1, 2027, for the rules found in 11 NCAC 01 and 17.

Given the amount of agency rules falling under the current periodic review schedule, please find a broad, tentative timeline pursuant to 26 NCAC 05 .0212 as follows:

- January 2026 June 2027
  - Review rules and identify potential need for substantive changes for readoption of all rules in chapters 01 and 17 of title 11 of the NCAC
  - Communicate with the Office of State Budget Management for fiscal notes if necessary
  - File Notice of Text within the second quarter
  - o Schedule Publication in accordance with 2026 RRC Publication schedule
  - Notify interested parties
  - o Hold Public Comment period in accordance with G.S. 150B-21.2(e)
  - Hold Public Hearing if necessary
  - o Review all public comments received by agency
  - o Adoption of rules in accordance with G.S. 150B-21.2(g)
  - o Submission of rules to RRC within 30 days of adoption

At this time, DOI has not identified any specific rulemaking priorities that would be relevant to the above readoption timeline.

Please let me know if any more is needed for the abovementioned rules under review.

The attached periodic review reports have been finalized. The next step is to set a deadline for the readoption of these rules. Pursuant to G.S. 150B-21.3A and 26 NCAC 05 .0212, the RRC sets this deadline after consultation with the agency, and this email serves as the RRC's request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

It appears that the deadline for your agency to provide this information is June 24, 2025. As a starting point, I would recommend a July 1, 2027 readoption deadline, but I am open to considering a different recommendation based on the needs of your agency.
