The Office of the State Fire Marshal accepts the proposed readoption deadline of **December 1, 2028** for the rules in 11 NCAC 05A, 05D, and 07. In light of that readoption deadline, we anticipate publishing notice of the proposed text of the rules in the first quarter of 2028 to allow for a robust public comment period and – if the State Fire Marshal decides to make substantial changes to the rules following that public comment period – enough time to re-publish the rules and proceed through a second public comment period. Pursuant to G.S. 150B-21.2(e), the public hearing will be held at least 15 days but not later than 60 days from publication. The State Fire Marshal will then adopt the rules after the expiration of the public comment period.

Please let me know if this email provides all the details regarding the Office of the State Fire Marshal's planned timeline for readoption required by 26 NCAC 05 .0212.
