4	(a) Any person submitting a petition to adopt, amend, or repeal a rule by the Board shall address a petition to the
5	Board's Rule Making Coordinator at the office address in 21 NCAC 32A .0101.

7	(a) for petitions to adopt or amend a rule, a draft of the proposed rule or amendment;
8	(b) a statement of the effect of the requested rule change; and
9	(c) the name and address of the petitioner.
