Seth,

The EMC chair is concerned about pushing deadlines back on the rule readoption schedule. We are hoping to revise the 11 rules in Subchapter 02I at the same time as the 3 rules in Subchapter 02A, as both subchapters concern EMC operating procedures. (I recognize that Subchapter 02A is only in front of the RRC for the Designation Report in December, but once the 60 days pass and the report is final, we want to make sure the 02I and 02A rules are reviewed together.) Some of the rules in those subchapters have not been updated in over 30 years, and we are hoping to revise all 14 rules sooner rather than later, so would suggest we maintain the November 2027 deadline for both Subchapters 02I and 02A, if not even making the deadline earlier. Again, due to the significant amount of time that has passed since the rules were revised, having a deadline as early as July 2027 would be preferable to any delay.

For the 02L, 02N, 02O, and 02P rules, we would prefer to continue to have the final deadline set as September 1, 2028, as proposed.

I appreciate your and the RRC's consideration of both EMC requests.

Jennifer,

I have received these and am happy to try and get them on the December agenda. For context, I had not yet sent out the consultation emails for the last batch of rules because of other time-sensitive priorities for the RRC. The timeline for starting the consultation process (by an email from a staff attorney) is flexible under the statute and rule, but once I start that process the other deadlines come into play. So in effect, the delay in following up with the consultation email gives the agency extra time. That said, we can treat this as the email requesting consultation pursuant to 26 NCAC 05.0212.

In regards to your proposed deadlines:

15 NCAC 02G: I can recommend setting the readoption deadline for these seven rules as December 1, 2028. Awesome.

15A NCAC 02I: Given what we already have scheduled for November 2027, I would propose that we set the readoption deadline for these eleven rules for December 1, 2027. Do you have any concerns with that? Nope, that works.

15A NCAC 02L, 02N, 020, and 02P: These sections have 137 rules. Given what we've already scheduled, the size of this package, and your proposed timeline, I'd like to push this back to 2029. Would August 1, 2029 would work for you? I think so. The EMC had approved a schedule that sectioned these 137 rules out into groups, with interim readoption dates, as identified in the filed readoption schedule. The first group identified, Group A (34 rules) will likely stay on the scheduled track, however. My understanding is that agencies can bring rules sooner than the readoption date.

Proposed Rule Readoption Schedule and Deadline 15A NCAC 02L, 02N, 02O, and 02P

The Environmental Management Commission (EMC) submits the following information for 15A NCAC 02L, 15A NCAC 02N, 15A NCAC 02O, and 15A NCAC 02P for the Rules Review Commission's consideration in setting the readoption deadline for these four subchapters.

Rulemaking Priorities and Rationale

Collectively, these four subchapters have 137 rules categorized as necessary and requiring readoption. The readoptions will be completed in three groups. A description of each group, along with the rationale, is provided below.

Group A: 34 rules in Subchapter 02L, Sections .0100 - .0300

These 34 rules in Subchapter 02L covering groundwater quality standards and classifications are administered by the Division of Water Resources (DWR). DWR proposes to keep their Division's 02L rules in one rulemaking package and separate from the Division of Waste Management's (DWM) rules. This is more efficient for staff, the commission, and the regulated community. A portion of these rules are also a part of North Carolina's Triennial Review of Groundwater Quality Standards.

Group B: 73 rules in Subchapters 02N, 02O, and 02P

These rules covering Underground Storage Tank (UST) Criteria and Standards, UST Financial Responsibility Requirements, and the Commercial Leaking Petroleum UST Cleanup Fund are administered by DWM's UST Section. DWM UST Section staff are interested in completing this readoption quickly while still allowing sufficient time for stakeholder engagement, because this readoption will be quickly followed by the readoption of Subchapter 02L, Sections .0400 and .0500.

Group C: 30 rules in Subchapter 02L, Sections .0400 - .0500

These 30 rules in Subchapter 02L covering Risk-Based Assessment and Corrective Action for Petroleum USTs and Petroleum Releases from Above-Ground Storage Tanks (ASTs) and Sources are administered by DWM's UST Section. DWM proposes to keep their Division's 02L rules in one rulemaking package and separate from DWR's rules. This is more efficient for staff, the commission, and the regulated community without overwhelming anyone with too many rules at once. The same staff that will be working on the readoption of these rules are also working on the readoption of 15A NCAC 02T Section .1500 through 2026 and early 2027.

Planned Timeline for Readoption

The EMC's planned timeline for readoption, including all steps required by G.S. 150B-21.2, will be accomplished by completing the rulemaking in three groups as detailed above, with a final adoption deadline for all rules in 15A NCAC 02L, 15A NCAC 02N, 15A NCAC 02O, and 15A NCAC 02P by September 1, 2028.

The Environmental Management Commission (EMC) submits the following information for 15A NCAC 02G for the Rules Review Commission's consideration in setting the readoption deadline for this subchapter.

The EMC proposes that the readoption deadline, including all steps required by G.S. 150B-21.2, be accomplished by completing the rulemaking as detailed below, with a final adoption deadline for all rules in 15A NCAC 02G by **December 1, 2028**.

For ease of reference, a table listing the proposed group and readoption deadline is included after the narrative rulemaking priorities and rationale below.

Rulemaking Priorities and Rationale

This subchapter has seven rules categorized as necessary and requiring readoption. The readoption will be completed along with the O2E - Water Use Registration and Allocation rules which has similar stakeholders who have discussed these rules in the past. The O2E rules comprises of Registration of Water Withdrawals and Transfers, Regulation of Surface Water Transfers, Central Coastal Plain Capacity Use Area, Water Use During Droughts and Water Supply Emergencies. A description of the group, along with the rationale, is provided below.

Seven rules in Subchapter 02G

Proposed Readoption: December 1, 2028

These rules covering the water storage allocation of Jordan Lake water supply are implemented by the Division of Water Resources (DWR). The Jordan Lake water supply storage is vitally important to the Triangle Region, the economic engine of North Carolina. It is important to have the objective, fact-based process for allocating that storage as provided by this rule.
