- Chapter 03 is a significant section within Title 19A. Collectively, the rules in Title 19A address modes of transportation and the rules in Chapter 03 specifically govern the Division of Motor Vehicles (DMV).
 DMV oversees driver licensing, examiner training and certification, vehicle registration, vehicle safety inspections, rental vehicles, dealerships, school bus, and traffic safety in accordance with G.S. 20.
- 2. Chapter 03 includes general and program specific rules governing all areas of the DMV's oversight including programs and procedures for certifications, licensing, and training. The readoption of Chapter 03 is complex regarding subject matter and impact to the general public. Variations to a rule can impact school systems, license plate agencies, inspection stations, etc. The regulated public for Chapter 03 is varied and there is not a lot of overlap. As of June 2025, there are 7.7 million licensed drivers, 950,000 state-issued IDs, and 10.8 million registered vehicles in North Carolina.
- 3. DMV and the State Highway Patrol are currently working to transfer the DMV License and Theft Bureau to the State Highway Patrol per Session Law (SL) 2024-57. SL 2024-57 establishes the State Highway Patrol as a principal department as codified in GS 143B-6(16) and defined in GS 143B-1700. This will necessitate a review of applicable rules for transfer and may require further amendments to any rules that have been readopted.
- 4. The DMV is in a period of transition with a new Secretary of Transportation and DMV Commissioner receiving and issuing directives to improve the user experience at driver's license offices and tag agencies as well as modernizing all IT. Ultimately, readoption of rules during a time of transition is likely to result in the need for further amendments to readopted rules. We would prefer time to consider changes to Chapter 03 in line with changes the transition will likely require of the remaining DMV rules.
- 5. Finally, the agency had all six chapters of periodic review due to the RRC within a four-month period, all of which will require readopting dates.

- 1. DMV is undergoing substantial review and updates to all systems and programs. This will include applicable administrative code, as well as the 2025 periodic review and subsequent readoption rule-making actions. With so many of the rules impacting the general public, the agency would like to limit the number of updates to rules and include a much as possible in a single initiative.
- 2. Completing the transfer of the License and Theft Bureau to the State Highway Patrol will require additional consultation with another agency to ensure that all necessary rules are in the correct chapters of the code.
