Re: MFC 210-day waiver granted by RRC

Dear Ms. Everett:

At its February 28, 2024 meeting, the Rules Review Commission (RRC) voted to grant the Marine Fisheries Commission (MFC) waiver request to submit temporary rules, as outlined in the MFC's letter sent to Chair Jeanette Doran on February 23, 2024, for Session Law 2023-137, Section 6.

General Statute 150B-21.1(a2) requires a temporary rule based upon a legislative change to be submitted to the RRC within 210 days of the enactment of the legislation. Session Law 2023-137, Section 6 became law on October 10, 2023 and the MFC was required to submit temporary rules no later than May 7, 2024. Pursuant to G.S. 150B-21.1(a2), the RRC has waived the 210-day requirement for temporary rulemaking for 60 days from May 7, 2024. The RRC's waiver is effective until July 6, 2024, which is 60 days from May 7, 2024.
