(1) comments/objections will be accepted up until 5pm of the day the meeting is held by the RRC (in this case, which is July 31st) This would be for submitting letters requesting legislative review.

(2) comments/objections for any rule being considered at the July 31st meeting is July 24<sup>th</sup> The deadline to submit comments on a **permanent rule** is 5 business days before a meeting so in this case it's the 24<sup>th</sup>. Good morning Alexander.

I spoke with you a few weeks ago about a particular rule being submitted from the North Carolina State Board of Dental Examiners (NCSBDE) for consideration by the Rules Review Commission. The particular rule is 21 NCAC 16H .0104.

I do see this rule is on the agenda for the upcoming July meeting. In reviewing the initial review by the Rules Review Commission (RRC) staff, I have a few things I would like clarification on.

On page 7, there is a title of **DEADLINE FOR RECEIPT of July 5, 2024.** Can you explain what this means? This deadline is for the agency to respond to the request for technical changes that the attorney is requesting.

Also, there are suggestions by the RRC staff and at the bottom, it asks for this to be retyped and resubmitted to the RRC office. Is this requesting the NCSBDE retype this or the staff retype and then resubmit to the RRC. This is for the agency to make the requested changes and submit the revised version of the rules back to the attorney. If this is asking the NCSBDE to retype and submit, if they do not wish to make these changes, what happens next? If the agency does not make the changes requested and the rule is deficient as follow: the agency lacks statutory authority to promulgate the rule, the rule is unclear or ambiguous as written, is unnecessary, or fails to comply with the APA, the attorney may issue a staff opinion to the RRC recommending objection to the rule.

Will this still be reviewed by the RRC in the current format? If the agency refuses to make changes, yes, the original version of the rule will be before the RRC.

Per your explanation regarding comments above, I'm assuming the RRC is receiving comments of objection for any rule being reviewed for the July meeting now and until the end of day of the July meeting? The deadline to submit comments for this meeting is July 24, 2024, All comments objecting any rule will be made public on the RRC website with the individual making the objection's name, etc? yes

Is making an objection different than requesting a legislative review, meaning does someone need to make both? Yes, you will need to do both. I did read that if the RRC receives at least 10 objections to the rule being considered, it will automatically go for legislative review. Am I understanding this correctly? Yes 10 or more will send the rule to the General Assembly for review if the rule is approved by the RRC at the meeting. If RRC objects to the rule, it remain on the agenda for the following months until the issues with the rule are resolved. If so, how does someone follow when this particular rule moves to legislative review, like the timeline of when it moves to the legislature, when it will be in review, what committee it is assigned to, etc? The rule with the letters will be sent to the General Assembly following the meeting. If the Administrative Procedure Oversight Committee meets and adds the rule on their calendar, they may take up the rule at that time and render a decision. If APO does not meet and 61 days has passed, the rule goes into effect. You can contact our office at that time to confirm.

Thank you so much for helping me understand this process. I'm trying to stay abreast and learn as much as I can and am very interested. Thank you also for your time!

I would like to have a little clarification regarding a proposed rule change that the NC State Board of Dental Examiners (NCSBDE) recently voted to change/amend.

The Rule in question is 21 NCAC 16 H .0104. The NCSBDE voted/approved final wording for amendments to 21 NCAC 16 H .0104 and voted to forward the Rule to the North Carolina Rules Review Commission for final adoption.

Is it possible for you to tell me when the Rules Review Commission will consider/accept this change, the newly revised rule to become in effect and when comments/objections will be accepted? We have not received this Rule for the June meeting. If they file it for RRC review it may possibly be for the July meeting. The deadline for the July meeting is June 20<sup>th</sup> so it can come in any time before the 20<sup>th</sup>.

I did see where comments/objections will be received until 5:00pm the day after the Rules Review Commission approves any rule. Yes, comments objecting to the rule when it is filed for RRC review will be sent to <a href="rrc.comments@oah.nc.gov">rrc.comments@oah.nc.gov</a> and will be posted on our website. Comments will be accepted up until 5pm of the day the meeting is held. Additionally, <a href="letters requesting legislative review">letters requesting legislative review</a> can be submitted until 5pm the date of the meeting. The agenda for each month is published on the 1st of each month <a href="here">here</a>. If it's filed for the July meeting, it will be posted here on July 1st.
