 - 2) is current as to all fees payable to the Board as of the date of the application request; and
 - 3) <u>has not been the subject of a disciplinary order that imposed a sanction that included supervised probation,</u> suspension, revocation or restoration of a revoked license during the 10-year period preceding the date of the application request for a Class II plumbing or heating license.
