The attached periodic review reports became effective October 29, 2024. The next step is to set a deadline for the readoption of these rules. Pursuant to G.S. 150B-21.3A and 26 NCAC 05 .0212, the RRC sets this deadline after consultation with the agency, and this email serves as the RRC's request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

The deadline for your agency to provide this information is **January 6, 2025**. As a starting point, I would recommend a **February 1, 2027, readoption deadline**, but I am open to considering a different recommendation based on the needs of your agency.
