Hi, Travis,

It's an unusual situation, so I can understand why the commission might ask. As explained below, I'm not sure it makes a difference either way, and I'm happy to have the report reflect either option.

We didn't select anything on the report because these rules no longer are in the code, and we didn't think it made sense to make a selection (including "agency did not review") on a report reviewing rules in the code if they were no longer in the code. "Agency did not review" seems like it would apply when an agency declined to review rules in the code, not when the rules were no longer relevant because they weren't in the code anymore. But if you think it makes more sense for us to select "Agency did not review," that's fine with me – unless I'm overlooking something, it seems like the outcome is the same regardless, and I don't have strong opinions one way or the other.
