The section intent is clarified as follows: 107.1.5 Sheathing inspection. Required for structures constructed under the NC Building Code in 140 mph wind zones or higher where the exterior sheathing is part of the lateral force resistance system. Required for dwellings constructed under the NC Residential

Brian Liebman Commission Counsel Date submitted to agency: April 19, 2024 Code in 140 mph wind zones or higher where the exterior sheathing is part of the wall bracing system. Sheathing inspection shall be made during or after the framing inspection, but before the water-resistant barrier and exterior finish is installed.
