The Rules Review Commission staff has completed its review of this Rule prior to the Commission's next meeting. The Commission has not yet reviewed this Rule and therefore there has not been a determination as to whether the Rule will be approved. You may email the reviewing attorney to inquire concerning the staff recommendation.

In reviewing this Rule, the staff recommends the following changes be made:

The table doesn't reflect when the agency sends the petition to OAH. Under 150B-20(a), an agency must send a rulemaking petition to OAH for publication on our website within 3 business days of receipt. NCBCC rulemaking coordinator response: Clarified the intent as follows in the table:

Rule Petition Sent to the North Carolina

Office of Administrative Hearings Pursuant

to N.C.G.S. 150B-20(a) for Posting to the

Public Within Three Business Days: February 1

What is a "standing committee"? I assume we're talking about the two committees created in G.S. 143-136? NCBCC rulemaking coordinator response: No. The standing committees are noted in 2024 NCACP 202.8.2 as follows:

202.8.2 Standing committees. The standing committees shall consist of members of the Building Code Council. The Chair of the Building Code Council shall appoint the chair and members of each committee.

The standing committees are listed in the front of the 2024 NCACP for each of following areas: Administration, Building, Electrical, Energy, Existing Building, Fire Prevention, Mechanical, Residential and Structural. These respective standing committees provide the first review and consideration of new rule petitions prior to the super committee review and consideration and the NCBCC review and consideration.

A recommendation of granting a new rule petition is then sent to the super committees for their consideration. If a standing committee denies a petition, the petition does not move forward in the process.

No changes were made per this comment and response.

What does it mean that the petition is "granted for public hearing"? Under G.S. 150B-20 a petition is either granted, and the agency goes through rulemaking, or it is denied, and the agency submits a written statement to the petitioner explaining the reason for denial. NCBCC rulemaking coordinator response: The NCBCC needs time to review new rule petitions once they receive them in February. The Mid-March meeting is where the NCBCC determines if the submitted new rule petition needs modifications by the proponent or not. A new rule petition is required to have a public hearing and be noticed in the NC Register which cannot happen in Mid-March per the receipt schedule and law for an item received in February since the deadline for the notice of hearing is too soon after the new rule petition has been received. Since the NCBCC meetings are quarterly, the public hearing is scheduled for Mid-June so that the item can be properly noticed in the NC Register. "Granted for Public Hearing" is stating that the NCBCC granted the item to proceed to rulemaking proceedings as noted in N.C.G.S. 150B-20(c). No changes were made per this comment and response.

Which April NC Register? Typically, rules must be filed between 20-30 days before the publication date of the Register (see the 2024 Publication Calendar on our website). For instance, this year, to make it in the April 1 Register, you'd have to have filed by March 8. To make it in the April 15 Register, you'd have to have filed by March 22. NCBCC rulemaking coordinator response: Mid-April NC Register posting to allow for the public hearing and 60-day public comment period to occur before the NCBCC adopts the rule just after the public hearing and expiration of the 60-day comment period. Clarified the intent as follows:

Rule Petition Granted for Public Hearing: Hearing (B-items):

MarchMid-March BCC meeting

Notice of Hearing Published:

AprilMid-April NC Register

Under SL 2023-134, 150B-21.2(e) was amended to add a requirement that hearings be held not later than 60 days after publication in the Register. So if you published in the April 1 Register, you could not have a hearing after 5/31. If you published in the April 15 Register, your hearing couldn't be later than June 14. Your rule states that the hearing would be at the June public hearing. I don't know when that is, but this is potentially misleading, as you'd be required to have a hearing in May if you published in the April 1 Register. NCBCC rulemaking coordinator response: The public hearing would occur pursuant to law noted in N.C.G.S. 150B-21.2(e). The intent is clarified as follows:

Hearing Held: Held (C-items): June Mid-June BCC public hearing (no later than 60 days from the NC Register publication date)

It seems you're proposing to have the hearing, the Standing Committee final review, and the full BCC adoption at the same June meeting. An agency cannot adopt a rule until the time for commenting has elapsed. The earliest time your comment period could elapse is 5/31 if you published on 4/1, and 6/14 if you published on 4/15. Thus, if your meeting is before 6/14, you'd be out of compliance with the APA. NCBCC

rulemaking coordinator response: The NCBCC would perform this action over two meetings in Mid-June. The public hearing would occur day one pursuant to law noted in N.C.G.S. 150B-21.2(e). The standing committee final review and NCBCC final adoption would occur on day two no earlier than the day after the public hearing and the expiration of the 60-day public comment period. The intent for standing committee final review and NCBCC final adoption to occur after the public hearing and the 60-day public comment period has expired is clarified as follows:
