

Rules Review Rule Readoption Process and Timeline

Readoption Date: June 1, 2027

The Board must submit written documentation of the Board's planned timeline for readoption, providing planned dates for all steps required by G.S. 150B-21.2

- The Board will prepare or obtain a fiscal note, if required **by August 2026**
- A notice of text for the rule will be published in the North Carolina Register **by October 2026**
- The Board will hold a public hearing on the proposed rule after publication of the proposed text of the rule by **November 2026**
- The rule will be open for public comment **October 2026 – December 2026**
- The Board has no rulemaking priorities that the agency determines to be relevant to the timeline for readoption.

Thank you for your prompt response. This is all I needed from you.

I will recommend the June 1, 2027 readoption deadline at the upcoming RRC meeting. Pursuant to G.S. 150B-21.3A and 26 NCAC 05 .0212, the RRC sets this deadline after consultation with the agency, and this email serves as the RRC's request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

It appears that the deadline for your agency to provide this information is May 22, 2025. As a starting point, I would recommend a June 1, 2027 readoption deadline, but I am open to considering a different recommendation based on the needs of your agency.
