Thanks, Jennifer. To clarify, if the CPH votes to amend the Rule to comply with the G.S. 150B-21.6 objection by the RRC, will CPH "(1) Change the rule to satisfy the Commission's objection and the submit the revised rule to the Commission" within 10 days of August 6<sup>th</sup>?

I'm asking because the Staff Opinion adopted by the RRC states, "Beyond ensuring public access to incorporated materials after codification, it is reasonable to infer from the language of G.S.150B-21.2 that the General Assembly intended for the public to have ready access to referenced materials during the comment period. Amending the rule after the comment period does not cure the deficiency of public access at the critical time for review and comment, which the statute is designed to protect." This seems to indicate the RRC also objected based on a substantial change made post-publication that requires republishing the Rule and accepting public comments.

Line 6: Explain how Rule .0102(b) provides the opportunity for inspection of 40 CFR 141, Subpart Z.

Agency Response: Upon reexamination of 18C .0102 (a) and (b), we agree that the statutes included in (a), and the specific citation of "40 C.F.R 141.2" in (b), are inadequate to provide an unambiguous opportunity for public inspection of the new federal PFAS regulations. As a remedy, we propose a change in proposed rule language that will provide ready access to Subpart Z. Please see that attached, revised rule.
