This note is regarding 15A NCAC 07H. 0314 - Installation and Maintenance of Wheat Straw Bales for Sand Fencing.

For over 25 years, I taught a course at UNC Greensboro called Biology and Conservation of Sea Turtles. The students and I monitored nesting beaches in North Carolina and in Costa Rica at the Caribbean Conservation Corporation's Biological Research Station in Tortuguero, Costa Rica. Over the course of those many years working in Costa Rica, I witnessed hundreds sea turtles crawling up beaches and successfully nesting and those failing to nest for a variety of natural and unnatural causes. The environmental conditions in North Carolina and in Costa Rica are vastly different, even so, comparisons can be made when it comes to the proposal to place straw bales on our beaches.

One of the primary causes for turtles failing to nest is encountering obstacles both on the sand while crawling up the beach and in the nesting area once digging begins. Both are potential hazards of straw bales being used as sand fencing.

From the biologist's perspective the idea of placing straw bales on the dunes seems ill-conceived and one that needs to be seriously thought out before being accepted. My request is that the rule be carefully reviewed in the upcoming legislative session as set out in N.C. Gen. Stat. § 150B-21.3. Additionally, I request that the rule be subject to a delayed effective date as set out in that same provision.
