Subject: .1724 fostering children of offenders Your Questions or Comments:

I'd mail this but by the time the letter would reach you, they'll be moved. The two toddlers we've raised for the last 16 months will be displaced again. We were their 4th placement in two months. She was not-yet two when we got the pair (her and her younger brother—so close in age, only 9 months apart) both drug exposed, both with developmental and behavioral concerns, both in the kind of “shell” that you would easily recognize if you have ever seen a child in foster care who has been moved multiple times. It took several weeks to get her to start talking again after their move to our home and months before her anxiety subsided and trust could begin to build. For 16 months, we have worked with social workers, therapists, and with her birth mother to close the substantial delays in their development and give them the best chance we can for success. For 16 months, we have given unwavering attention and love to these children.

In one more month, they are scheduled to return home. It should have been seamless. It should have followed the progressive plan established by social workers, the guardian-at-litem and approved by a judge to reduce trauma, regression and be a healthy transition for the children. So much for that.

Instead, because of a state-wide department policy, in six days, they will be moved to another family, another home, another daycare, another start, another end, another transition and another loss in their little lives. The new family won't know what these children have overcome and accomplished while in foster care. The new family probably won't understand their emerging speech and won't recognize what their needs are because they don't know or can't discern the vocabulary of the children. They won't know how we put shirts on and pretend we can't find our arms. They won't know how we pick the illustrated apples off the tree and share them with each other when we are reading the Winnie the Pooh colors book, or pretend to throw snowballs at each other when we read



Elmer's Weather. They won't know how the plastic-eyed plush turkey gobbles across the little one's bed each night to tuck him in and kisses his face all over then hops into his arms before!

turn off the light. They won't understand why the older one expects her toy bunny to bounce into her arms saying "ribbit" instead of "boing." Toothbrushing, getting dressed, where we put our shoes, how we say "Goodbye" at the doorway to our preschool class, what toys are the bath time favorites, how we like our hot dog cut and the pictures we draw with ketchup, the little dresser handle next to his bed that he flips up and down to help him fall asleep, all those precious routines will be stripped out of their lives and they are not even old enough to understand why.

For more than a year, I've been working with the mom to support and encourage her and keep her abreast of the progress, routines, challenges and accomplishments of her children. I've written her letters and sent her pictures throughout the process. I've gone over and beyond to ensure that IF the children were to go home, they would have as smooth a transition as possible. Three weeks before they are supposed to move home, this happens. Dad is getting released from prison early. The kids don't even know him. DSS is not even considering him as a placement option. He'll be in another county supervised by officers we will likely never meet. But because he is a biological parent and has rights, and because he will be supervised-- in another county by another agency--these children, who know nothing of him, must be torn from the family they love.

My husband did not want me to write this letter and I respect his wishes enough to make this anonymous as much as I would love to sign my name to it. He works for probation and parole and we have been fostering children for more than 10 years. You have a rule in your system that employees working in probation and parole cannot foster children whose parents are under active supervision. Unfortunately those factors collide in the Venn Diagram often and it is the children that pay the price. It can cost an adoptive family the child they love and it can force a child to grow up without the family that took the chance to love them, even when things were really, really hard.

I will keep this "short" because I could go on with this for pages without losing steam, but I am asking you to please consider revising this policy to preserve the intent that needs to be preserved but consider modifications. If a parent is being supervised in the same county as the children are fostered, I understand the conflict and it seems appropriate for the policy to be in place. If the children are being fostered by someone who has any type of professional contact with the parents, it seems appropriate for the policy to be in place. But if they do not...if there is no overlap whatsoever, please do not force the "immediate exit plan" to uproot the children. At minimum, please allow a grace period for social workers to decide if they are going to terminate parental rights, reunify the child with parents or relatives, or if they must locate another family. Please, at minimum, give social workers the chance to act in the best interests of the children. Plea!
