6. The Transcriptionist agrees to deliver the transcript to the Requestor and to each person or entity that the Requestor has identified as a party to the proceeding in a text-born, fully searchable, unsecured PDF file.

7. The Transcriptionist agrees to file the transcript with the Office of Administrative Hearings by email to oah.clerks@oah.nc.gov in PDF format.

8. The Transcriptionist agrees that the Requestor may reproduce the transcript, prepare derivative works from the transcript, distribute copies of the transcript, and display the transcript publicly.

9. The Transcriptionist agrees that the Requestor may terminate this contract at any time prior to the delivery of the transcript. The Requestor agrees that if this contract is terminated, the Requestor will pay the Transcriptionist for all work that the Transcriptionist has completed at the time of the termination.

10. The Requestor and the Transcriptionist may agree by addendum to additional terms, but those additional terms do not supersede these terms.
