My Comment Text: I believe that section (g)4 should be changed to allow a field test for chlorides instead of requiring a test by a state certified laboratory. The Div. of Water Quality Groundwater Management Branch uses the Quantab field chloride titration method of testing in their triannual chloride survey. If this method is sufficiently accurate for state testing it should be more than adequate for permit reporting purposes.
