

Ed,

Since you are familiar with the water resources rules, you probably understand the rules process, but I asked someone in the Department for some explanation.

The review process (statutorily mandated) required a look at every rule in the state's administrative code. The agency of record looks at the rule and classifies it as "necessary with substantive interest", "necessary without substantive interest", or "unnecessary". Those classifications are currently out for public comment for understanding of whether the public agrees with how we've classified them. Most of this is laid out on the rules page http://www.ncdot.gov/about/regulations/rules/periodicReview.html

Kym's answer or assumption does drive some of those rule determinations. If state funding is not allowed for an activity, then the rules dictating how state funds are spent on that activity are no longer current. Similarly, if laws have changed that no longer require the administrative code or rule, then that would have negated the need for the rule. Also, there were several older rules that were never official rules to begin with. They may have been Board of transportation actions or administrative actions mistakenly documented as rules for administrative code.

I hope this helps.

As I'm sure you know North Carolina is going through a "rules review" process, mandated by the legislature a couple of years ago. Each agency has to go through all their rules and assign them to specific categories. http://www.ncleg.net/EnactedLegislation/Statutes/HTML/BySection/Chapter 150B/GS 150B-21.3A.html

NCDOT has issued its preliminary reports for the rules labeling each rule as either necessary with substantive interest, necessary without substantive interest, or unnecessary. http://www.ncoah.com/rules/H74%20Reports/19A%20NCAC%2006.pdf

A rule is labeled unnecessary if the agency determines it to be "obsolete, redundant, or otherwise not needed."

Among the rules listed as "unnecessary" are 19A NCAC 06D .0202, .0204, .0205, .0206. Because these have to do with Bike lanes etc, I thought you might have some insight as to why these are deemed unnecessary. I haven't looked into this matter very deeply yet, but it may be simply a product of the fact that there is no longer state funding of standalone bike/ ped facilities.

I will look into this further but wanted to check in to see if you had any knowledge / insight first.
