#### INFORMATION ABOUT THE NORTH CAROLINA REGISTER AND ADMINISTRATIVE COD

#### NORTH CAROLINA REGISTER

The North Carolina Register is published bi-monthly and contains information relating to agency, executive, legislative and judicial actions required by or affecting Chapter 150B of the General Statutes. All proposed, administrative rules and amendments filed under Chapter 150B must be published in the Register. The Register will typically comprise approximately fifty pages per issue of legal text.

State law requires that a copy of each issue be provided free of charge to each county in the state and to various state officials and institutions. The *North Carolina Register* is available by yearly subscription at a cost of one hundred and five dollars (\$105.00) for 24 issues.

Requests for subscriptions to the *North Carolina Register* should be directed to the Office of Administrative Hearings, P. O. Drawer 27447, Raleigh, N. C. 27611-7447, Attn: *Subscriptions*.

## ADOPTION, AMENDMENT, AND REPEAL OF RULES

An agency intending to adopt, amend, or repeal a rule must first publish notice of the proposed action in the North Carolina Register. The notice must include the time and place of the public hearing; a statement of how public comments may be submitted to the agency either at the hearing or otherwise; the text of the proposed rule or amendment; a reference to the Statutory Authority for the action and the proposed effective date.

The Director of the Office of Administrative Hearings has authority to publish a summary, rather than the full text, of any amendment which is considered to be too lengthy. In such case, the full text of the rule containing the proposed amendment will be available for public inspection at the Rules Division of the Office of Administrative Hearings and at the office of the promulgating agency.

Unless a specific statute provides otherwise, at least 30 days must elapse following publication of the proposal in the *North Carolina Register* before the agency may conduct the required public hearing and take action on the proposed adoption, amendment or repeal.

When final action is taken, the promulgating agency must file any adopted or amended rule for approval by the Administrative Rules Review Commission. Upon approval of ARRC, the adopted or amended rule must be filed with the Office of Administrative Hearings. If it differs substantially from the proposed form published as part of the public notice, upon request by the agency, the adopted version will again be published in the North Carolina Register.

A rule, or amended rule cannot become effective earlier than the first day of the second calendar month after the adoption is filed with the Office of Administrative Hearings for publication in the NCAC.

Proposed action on rules may be withdrawn by the promulgating agency at any time before final action is taken by the agency.

#### TEMPORARY RULES

Under certain conditions of an emergency nature, some agencies may issue temporary rules. A temporary rule becomes effective when adopted and remains in

effect for the period specified in the rule or 180 whichever is less. An agency adopting a tempora must begin normal rule-making procedures on to manent rule at the same time the temporary adopted.

# EXECUTIVE ORDER NUMBER 157 WAIVING CERTAIN PENALTIES PURSUANT TO CHAPTER 166A OF THE GENERAL STATUTES OF NORTH CAROLINA

WHEREAS, this year's cotton and peanut crops are the largest in recent years; and

WHEREAS, substantial portions of the crops may be lost if they are not removed from the fields before the onset of winter; and

WHEREAS, there is a substantial likelihood that the farmers of the state will not be able to remove their cotton and peanut crops from the fields before the onset of winter with the equipment now available to them for that purpose if they are required to adhere to the weight restrictions presently imposed by N.C.G.S. §§20-88, 20-96, and 20-118; and

WHEREAS, under the provisions of N.C.G.S. §166A-4(3) and 166A-6(c)(3), the Governor, with the concurrence of the Council of State, may waive the penalties for exceeding the weight limits imposed by said statutes in the event of an imminent threat of widespread damage from a natural or man-made accidental cause within the meaning of N.C.G.S. §\$166A-4(3) and 166A-6(c)(3); and

WHEREAS, with the concurrence of the Council of State, I have found that because:

 (i) they must adhere to the weight restrictions of N.C.G.S. §§20-88, 20-96 and 20-118, farmers will be unable to remove their cotton and peanut crops from the fields before the onset of winter,

(ii) their inability to do so likely will result in damages to their crops causing them to suffer losses and, therefore,

(iii) there is an imminent threat of widespread damage from a natural or man-made accidental cause within the meaning of N.C.G.S. §166A-4(3);

THEREFORE, pursuant to the authority vested in me by the Constitution and laws of this State and with the concurrence of the Council of State, it is ORDERED:

Section 1. The Division of Motor Vehicles shall waive penalties arising under N.C.G.S. §§20-88, 20-96 and 20-118 that otherwise would be assessed against vehicles transporting on the highways of the State unprocessed peanuts and unginned cotton to processing facilities.

<u>Section 2.</u> Notwithstanding the waivers recited above, penalties shall not be waived:

- (i) in those instances where the vehicle weight exceeds the maximum gross vehicle weight criteria established by the manufacturer, or
- (ii) for cotton module trucks having tandem axle weights in excess of 44,000 pounds.

Section 3. This Order shall be effective immediately and shall remain in effect until February 1, 1992.

#### TITLE 10 - DEPARTMENT OF HUMAN RESOURCES

The proposed effective date of this action is May 1, 1992.

Reason for Proposed Action: The State of North Carolina will lose approximately \$15 million in federal Medicaid funds unless the funds donated by hospitals to the Medicaid program are spent before January 1, 1992.

Oral comments may be presented at the hearing. In addition, a fiscal impact statement is available upon written request from the same address.

Editor's Note: This Rule has been filed as a temporary amendment effective on November 1, 1991 for a period of 180 days to expire on April 30, 1992.

CHAPTER 26 - MEDICAL ASSISTANCE

SUBCHAPTER 26H - REIMBURSEMENT PLANS

#### SECTION .0200 - HOSPITAL INPATIENT REIMBURSEMENT PLAN

#### .0206 PAYMENT ASSURANCE

(a) The state will pay each hospital the amount determined for inpatient services provided by the hospital according to the standards and methods set forth in this Section. In all circumstances involving third party payment, Medicaid will be the payor of last resort.

(b) If contributions are made pursuant to General Statute 143-23.2 during calendar year 1991, the Department has determined that it will

use them as follows:

(1) the Department will present the contributed funds to the federal government to be matched pursuant to federal financial

- participation rules. The total of the contributed and matched funds hereinafter will be referred to as the "Funds" to be disbursed in the order set forth in this Rule.
- the contributed funds will provide the total non-federal share of Medicaid expenditures made with the Funds.
- (3) up to forty million dollars (\$40,000,000) of the Funds will be used to fund elimination of the target day provision [as described in 10 NCAC 26H .0202(h)] for fiscal years 1990-91 and 1991-92, and to further other State Medicaid purposes for those fiscal years.
- (4) any remaining Funds, not to exceed one hundred forty million dollars (\$140,000,000), will be used to make an additional payment adjustment to disproportionate share hospitals for services provided in April, May and June, 1991, as provided in Rule .0204(g) of this Section
- (5) any remaining Funds, not to exceed twenty-two million five hundred thousand dollars (\$22,500,000), will be used first, to fund elimination of the target day provision referenced in Paragraph (b)(3) of this Rule for fiscal year 1992/93 and if any funds remain they will be used to determine hospital costs as a cost containment effort as authorized in Section 62, Chapter 1066 of the 1989 Session Laws, to fund Medicaid provider claim payments in November or December 1991.

(6) any remaining Funds, not to exceed one hundred sixty million dollars (\$160,000,000), will be used to make an additional payment adjustment to disproportionate share hospitals for services provided in July, August, September, October, November and December, 1991, as provided in Rule .0204(g).

(c) Contributed funds shall be earmarked and maintained in a segregated account in accordance

with General Statute 143-23.2(b).

#### CHAPTER 14 - GOVERNOR'S WASTE MANAGEMENT BOARD

SUBCHAPTER 14B - RULES OF PROCEDURE FOR IMPLEMENTING PRIVILEGE LICENSE TAX APPEAL

#### .0002 DEFINITIONS

As used in these Rules:

"Hearing" shall mean a contested case hearing as provided in G.S. 150B-23(a).

"Board" shall mean the Governor's Waste Management Board.

"Chairman" shall mean the Chairman of the Governor's Waste Management Board.

- (4) "Facility" shall mean any low-level radioactive waste facility as defined in NCGS 104E-5(9b) and any hazardous waste facility as defined in permitted under NCGS 130A-290(a)(9).
- (5) "Hearing Panel" shall mean any group of members of the Board appointed by the Chairman and delegated by him the authority to hear an appeal.

(6) "Hearing Officer" shall mean any person to whom the Chairman delegates authority to hear an appeal.

Statutory Authority G.S. 143B-285.13(12): 143B-285.13(14).

#### .0005 NOTICE OF APPEAL

Appeals of a tax rate shall be filed no later than 60 days after the levy of the tax in the case of a facility subject to the tax at the time of the levy. or no later than 60 days after notice that the tax is due in the case of a facility not subject to the tax at the time of the levy. after satisfaction of the requirements set out in Paragraph (b) of Rule .0003 of this Subchapter. An appeal shall be in writing and shall be mailed to the Governor's Waste Management Board. Department of Environment, Health, and Natural Resources, P.O. Box 27687, Raleigh, NC 27611. 27611-7687. The appellant shall cause a copy of the notice of appeal to be served upon the city or town levying the tax in question.

#### .0006 RESPONSE TO NOTICE OF APPEAL

(a) Notice of appeal to the Board will be acknowledged in writing and a form requesting any information necessary to perfect the appeal will be mailed to the appellant along with the acknowledgement. A copy of the letter of acknowledgement will also be sent to the Chairman of the Board of Commissioners and the attorney for the county, in the case of an appeal of a county tax, or the mayor and attorney for the city in the case of an appeal of a city tax.

Unless an extension is requested and granted, the requested information necessary to perfect the appeal must be returned within 30 days of the date the appellant receives the letter of acknowledgement or the appeal will be dismissed. The applicant shall send a copy of the requested information to the city or county attorney at the same time it is returned to the

(c) The acknowledgement will also transmit a date for hearing the appeal to be set by the Chairman. The date of the hearing shall be within 90 days of receipt of the notice of appeal, except that at the discretion of the Chairman, the date may be extended for good cause.

.0007 FILING OF AN ANSWER

- (a) The city or county that levied the tax being appealed shall file an answer within 20 days from receipt of the completed application, perfected appeal, and shall send a copy of the answer to the appellant at the same time it is filed with the Board.
- (b) The city or county's failure to file an answer shall not constitute waiver of the city city's or county's rights nor an admission of the appellant's allegations.

#### .0009 WHO SHALL CONDUCT A HEARING

The Chairman shall determine for each panel whether the matter appeal should be heard by the full board, a panel of board members, or a hearing officer, and shall notify the parties of the determination. The Chairman is hereby authorized to appoint board members to a panel or a hearing officer and to delegate to the panel or hearing officer authority to hear an appeal. The recommended decision made at this stage by the full board, a panel of the Board members, or a hearing officer shall be presented to the full board for final decision.


