In reviewing this Rule, the staff recommends the following technical changes be made:

Just to be clear, are you eliminating General Instructor Certifications entirely and replacing them with Probationary Instructor Certifications? If so, please review the title of this Rule.

In (a), line 6, do you mean "Section" instead of "Subchapter?"

In (a)(1)(B), please delete or define "directly."

At lines 22 and 35, please capitalize "State" if you are only referring to North Carolina. If you are referring to any state, please do not capitalize "state."

In (c), do they have to complete the exam again or only the training course?

In (d), what is considered an "equivalent instructor training course?" How does CJETS determine whether a training course is "equivalent?" What factors are considered?

In (d), lines 6-7, are the contents or substantive requirements of the application in a rule in accordance with G.S. 150B-2(8a)(d)?

At line 7, please capitalize "State" if you are only referring to North Carolina. If you are referring to any state, please do not capitalize "state."

In (e), line 9, please delete or define "substantially."

At line 10, Please capitalize "Paragraphs."

At line 11, please add a comma after "styles."

In (f), are you eliminating General Instructor Certifications entirely in this Rule? If so, please review the language in (f). If not, what is the difference between a general and a probationary instructor?

12 NCAC 09B .0302 is amended as published in 34:06 NCR 486-489 as follows:

#### 12 NCAC 09B .0302 GENERAL INSTRUCTOR CERTIFICATION

(a) A General Instructor Certification issued after December 31, 1984, shall be limited to those topics that are not expressly incorporated under the Specialized Instructor Certification category. Individuals certified under the general instructor category shall not teach any of the subjects specified in Rule .0304 of this Subchapter, entitled "Specialized Instructor Certification." To qualify for issuance of General Probationary Instructor Certification, an applicant shall demonstrate a combination of education and experience in criminal justice and proficiency in the instructional process by meeting the following requirements:

- (1) Present documentary evidence showing that the applicant:
  - (A) is a high school, college, or university graduate or has received a high school equivalency credential as recognized by the issuing state; and
  - (B) has acquired four years of practical experience as a Criminal Justice Officer, an administrator or specialist in a field directly related to the criminal justice system, or as an employee of a Criminal Justice Agency;
- (2) Present evidence showing completion of a Commission-accredited instructor training program or an equivalent instructor training course. course utilizing the Instructional Systems Design model, an international model with applications in education, military training, and private enterprise; and
- (3) Achieve a passing score on the comprehensive written examination administered by the Commission, as required by Rule .0413(d) of this Subchapter.
- (b) Applications for General Probationary Instructor Certification shall be submitted to the Standards Division within 60 sixty days of the date the applicant passed the state comprehensive examination administered at the conclusion of the Commission-accredited instructor training program. program or an equivalent instructor training course use the Instructional Systems Design model, an international model with applications in education, military training, and private enterprise.
- (c) Persons having completed a Commission accredited instructor training course or an equivalent instructor training course using the Instructional Systems Design model, an international model with applications in education, military training, and private enterprise, and not having made application within 60 days of completion of the course shall complete a subsequent Commission accredited instructor training course or an equivalent instructor training course utilizing the Instructional Systems Design model, an international model with applications in education, military training, and private enterprise, in its entirety.
- 32 (d) Applicants for Speed Measuring Instrument Instructor courses shall possess probationary or General Instructor
- 33 Certification.
- 34 (c) Persons having completed a Commission-accredited training course and not having submitted the application
- 35 within sixty days of the date the applicant passed the state comprehensive examination shall complete a subsequent
- 36 <u>Commission-accredited instructor training course in its entirety.</u>

Pursuant to G.S. 90-113.74E, did you consult with DOJ, the North Carolina Justice Academy, and SBI on the certification requirements for diversion investigators and diversion supervisors?

What is a diversion investigator or diversion supervisor? Are you using the definitions from G.S. 90-13.74(i)(7)?

In (a), consider deleting "be designed to" at line 4.

At line 5, please delete or define "proficiently."

A line 8, instead of "he or she" consider saying "the trainee."

At line 9, please do not use parentheses. Consider deleting the wording in the parentheses because this is already explained at lines 6-7.

At line 12, consider deleting the word "such."

At line 15, who are "appointed" deputy sheriffs? Does this refer to all deputy sheriffs?

At line 18, please review your reference to .0206. It has been repealed. Did you intend to reference another rule?

In (c), line 20, consider deleting "those" at the beginning of the sentence.

At line 20, please delete or define "previously."

At line 21, please capitalize "Rule."

1 12 NCAC 09B .0314 is adopted as published in 34:06 NCR 486-489 as follows: 2 3 12 NCAC 09B .0314 CERTIFICATION OF DIVERSION INVESTIGATORS AND SUPERVISORS 4 (a) The diversion training courses for investigators and supervisors shall be designed to provide the trainee with the 5 skills and knowledge to proficiently perform the duties of a law enforcement Diversion Investigator or Supervisor. 6 The diversion training course for investigators shall be twenty-four classroom hours. The diversion training course 7 for supervisors shall be administered in a four hour online training course. To be certified as a Diversion Investigator 8 or Diversion Supervisor he or she shall complete the respective diversion training course and achieve a minimum 9 score of 70 percent on the comprehensive written (Investigator) or online (Supervisor) examination. 10 (b) Only a Sheriff, deputy sheriff, or law enforcement officer certified or appointed through the North Carolina 11 Criminal Justice Education and Training Standards or North Carolina Sheriff Education and Training Standards 12 Commissions and employed by a law enforcement agency shall be enrolled in a diversion training course. Such a 13 trainee shall not be certified as a Diversion Investigator or Diversion Supervisor until the Basic Law Enforcement 14 Training course, pursuant to Rule 09B .0205 of this Chapter, has been completed with passing scores and probationary 15 or general law enforcement certification has been granted. Sheriffs and appointed deputy sheriffs shall be allowed to 16 participate in the diversion training courses on a space available basis at the discretion of the Diversion Training 17 Course School Director without having enrolled in, or having completed with passing scores, the Basic Law 18 Enforcement Training course, pursuant to Rule 09B .0205 and .0206 of this Chapter and without being currently 19 certified in a probationary status or holding justice officer certification. 20 (c) Those Special Agents with the North Carolina State Bureau of Investigation previously deemed Diversion 21 Investigators as of July 1, 2019, shall be automatically granted certification under this rule for a period of three years. 22 (d) The "Diversion Training Courses" required for certification, authored by the North Carolina State Bureau of 23 Investigation and published by the North Carolina Justice Academy, shall include the topic areas as outlined in NCGS 24 17C-6(a)(19) and is to be applied as the basic curriculum for the Diversion Training Courses for Diversion Investigator 25 and Diversion Supervisors as administered by the Commission. #### COMMENT:

Staff recommends objection for failure to comply with the APA. At lines 7-13, the agency incorporates a manual of approved training topics by reference, including subsequent amendments and editions. The Rule refers to the manual again at lines 29-31. Incorporating or referring to the manual rather than stating its contents in the Rule circumvents the permanent rulemaking process set forth in G.S. 150B-21.2. The list of training topics meets the definition of a "rule" in G.S. 150B-2(8a) and the list is proposed to be deleted at lines 14-27. As written, this Rule would allow the agency to amend the manual outside the rulemaking process, changing the substance of this Rule without public notice, comment, or RRC review.

Therefore, staff recommends objection to the language in lines 7-13 and 29-31 for failure to comply with the APA.

For the purposes of this Subchapter, a credit shall be equal to one hour of traditional classroom 7 instruction. All sworn law enforcement officers shall complete a minimum of 24 in-service training credits. Specific 8 topics identified in the Annual In-Service Manual and approved by the North Carolina Criminal Justice Education and 9 Training Standards Commission shall be as published by the North Carolina Department of Justice, Incorporated 10 herein by reference, and shall include any later amendments and editions of the incorporated materials as provided by 11 G.S. 150B-21.6. Topics delivered pursuant to Rule 33 .0104(1) of this Section and National Certification Programs administered by the International Association of 34 Directors of Law Enforcement Standards and Training (IADLEST) completed during the mandated in-service year, 35 shall satisfy in part or in whole the topic requirements set forth by the agency department head. To satisfy this 36 requirement these topics shall not be required to be written in Instructional Systems Design format or delivered by an 37 instructor certified by the Commission.

29		that are more than four credits in length shall include a written test comprising of a minimum of 20
