4 The following credentials and qualifications apply to staff described in this Subchapter:

5 (1) "Associate Professional (AP)" within the mental health, developmental disabilities and substance
6 abuse services (mh/dd/sas) system of care means an individual who is **either** a:

7 (a) graduate of a college or university with a masters degree in a human service field with
8 less than one year of full-time, post-graduate degree accumulated mh/dd/sa experience
9 with the population served, or a substance abuse professional with less than one year of
10 full-time, post-graduate degree accumulated supervised experience in alcoholism and
11 drug abuse counseling. Supervision shall be provided by a qualified professional with the
12 population served until the individual meets one year of experience. The supervisor and
13 the employee shall develop an individualized supervision plan upon hiring. The parties
14 shall review the plan annually; ~~or~~

15 (b) graduate of a college or university with a bachelor's degree in a human service field with
16 less than two years of full-time, post-bachelor's degree accumulated mh/dd/sa experience
17 with the population served, or a substance abuse professional with less than two years of
18 full-time, post-bachelor's degree accumulated supervised experience in alcoholism and
19 drug abuse counseling. Supervision shall be provided by a qualified professional with the
20 population served until the individual meets two years of experience. The supervisor and
21 the employee shall develop an individualized supervision plan upon hiring. The parties
22 shall review the plan annually; ~~or~~

23 (c) graduate of a college or university with a bachelor's degree in a field other than human
24 services with less than four years of full-time, post-bachelor's degree accumulated
25 mh/dd/sa experience with the population served, or a substance abuse professional with
26 less than four years of full-time, post-bachelor's degree accumulated supervised
27 experience in alcoholism and drug abuse counseling. Supervision shall be provided by a
28 qualified professional with the population served until the individual meets four years of
29 experience. The supervisor and the employee shall develop an individualized supervision
30 plan upon hiring. The parties shall review the plan annually; or

31 (d) registered nurse who is licensed to practice in the State of North Carolina by the North
32 Carolina Board of Nursing with less than four years of full-time accumulated experience
33 in mh/dd/sa with the population served. Supervision shall be provided by a qualified
34 professional with the population served until the individual meets four years of
35 experience. The supervisor and the employee shall develop an individualized supervision
36 plan upon hiring. The parties shall review the plan annually.

- 1 (2) "Certified clinical supervisor (CCS)" means an individual who is certified as such by the North
2 Carolina Substance Abuse Professional Practice Board.
- 3 (3) "Certified criminal justice addictions professional (CCJP)" means an individual who is certified as
4 such by the North Carolina Substance Abuse Professional Practice Board.
- 5 (4) "Certified substance abuse counselor (CSAC)" means an individual who is certified as such by the
6 North Carolina Substance Abuse Professional Certification Board.
- 7 (5) "Certified substance abuse prevention consultant (CSAPC)" means an individual who is certified
8 as such by the North Carolina Substance Abuse Professional Practice Board.
- 9 (6) "Clinical" means having to do with the ~~active direct treatment/habilitation~~ treatment or habilitation
10 of a client.
- 11 (7) "Clinical staff member" means a qualified professional or associate professional who provides
12 ~~active direct treatment/habilitation~~ treatment or habilitation to a client.
- 13 (8) ~~Clinical/professional~~ "Clinical or professional" supervision" means regularly scheduled assistance
14 by a qualified professional or associate professional to a staff member who is providing direct,
15 therapeutic intervention to a client or clients. The purpose of clinical supervision is to ensure that
16 each client receives treatment or habilitation ~~which that~~ is consistent with accepted standards of
17 practice and the needs of the client.
- 18 (9) "Clinical social worker" means a social worker who is licensed as such by the N.C. Social Work
19 Certification and Licensure Board.
- 20 (10) "Director" means the individual who is responsible for the operation of the facility.
- 21 (11) "Licensed clinical addictions specialist (LCAS)" means an individual who is licensed as such by
22 the North Carolina Substance Abuse Professional Practice Board.
- 23 (12) "Licensed clinician" means an individual with ~~full~~ clinical licensure awarded by the State of North
24 Carolina, as a physician, licensed psychologist, licensed psychological associate, licensed clinical
25 social worker, licensed professional counselor, licensed marriage and family therapist, or licensed
26 clinical addictions specialist. "Licensed clinician" also includes an individual with ~~full~~ clinical
27 licensure and certification as a certified clinical nurse specialist in psychiatric mental health
28 advanced practice, or a certified nurse practitioner in psychiatric mental health advanced practice.
- 29 (13) "Licensed professional counselor (LPC)" means a counselor who is licensed as such by the North
30 Carolina Board of Licensed Professional Counselors.
- 31 (14) "Nurse" means a person licensed to practice in the State of North Carolina either as a registered
32 nurse or as a licensed practical nurse.
- 33 (15) "Paraprofessional" within the mh/dd/sas system of care means an individual who, with the
34 exception of staff providing respite services or personal care services, has a GED or high school
35 diploma; ~~those or no GED or high school diploma,~~ employed prior to November 1, 2001 to
36 provide a mh/dd/sa ~~service.~~ service are not required to have a GED or high school diploma.
37 Supervision shall be provided by a qualified professional or associate professional with the

1 population served. The supervisor and the employee shall develop an individualized supervision
2 plan upon hiring. The parties shall review the plan annually.

3 (16) "Psychiatrist" means an individual who is licensed to practice medicine in the State of North
4 Carolina and who has completed a training program in psychiatry accredited by the Accreditation
5 Council for Graduate Medical Education.

6 (17) "Psychologist" means an individual who is licensed to practice psychology in the State of North
7 Carolina as either a licensed psychologist or a licensed psychological associate.

8 (18) "Qualified client record manager" means an individual who is a graduate of a curriculum
9 accredited by the Council on Medical Education and Registration of the American Health
10 Information Management Association and who is currently registered or accredited by the
11 American Health Information Management Association.

12 (19) "Qualified professional" means, within the mh/dd/sas system of ~~care:~~ care either:

13 (a) an individual who holds a license, provisional license, certificate, registration or permit
14 issued by the governing board regulating a human service profession, except a registered
15 nurse who is licensed to practice in the State of North Carolina by the North Carolina
16 Board of Nursing who also has four years of full-time accumulated experience in
17 mh/dd/sa with the population served; ~~or~~

18 (b) a graduate of a college or university with a Masters degree in a human service field and
19 has one year of full-time, pre- or post-graduate degree accumulated supervised mh/dd/sa
20 experience with the population served, or a substance abuse professional who has one
21 year of full-time, pre- or post-graduate degree accumulated supervised experience in
22 alcoholism and drug abuse counseling; ~~or~~

23 (c) a graduate of a college or university with a bachelor's degree in a human service field and
24 has two years of full-time, pre- or post-bachelor's degree accumulated supervised
25 mh/dd/sa experience with the population served, or a substance abuse professional who
26 has two years of full-time, pre- or post-bachelor's degree accumulated supervised
27 experience in alcoholism and drug abuse counseling; or

28 (d) a graduate of a college or university with a bachelor's degree in a field other than human
29 services and has four years of full-time, pre- or post-bachelor's degree accumulated
30 supervised mh/dd/sa experience with the population served, or a substance abuse
31 professional who has four years of full-time, pre- or post-bachelor's degree accumulated
32 supervised experience in alcoholism and drug abuse counseling.

33 (20) "Qualified substance abuse prevention professional (QSAPP)" means, within the mh/dd/sas system
34 of ~~care:~~ care, means either:

35 (a) a graduate of a college or university with a masters degree in a human service field and
36 has one year of full-time, post-graduate degree accumulated supervised experience in
37 substance abuse prevention; ~~or~~

- 1 (b) a graduate of a college or university with a bachelor's degree in a human service field and
- 2 has two years of full-time, post-bachelor's degree accumulated supervised experience in
- 3 substance abuse prevention; ~~or~~
- 4 (c) a graduate of a college or university with a bachelor's degree in a field other than human
- 5 services and has four years of full-time, post bachelor's degree accumulated supervised
- 6 experience in substance abuse prevention; or
- 7 (d) a substance abuse prevention professional who is certified as a Certified Substance Abuse
- 8 Prevention Consultant (CSAPC) by the North Carolina Substance Abuse Professional
- 9 Practice Board.

3 **10A NCAC 28A .0102 DEFINITIONS**

4 (a) In addition to the definitions contained in this Rule, the terms defined in G.S. 122C-3, 122C-4 and 122C-53(f)
5 also apply to all rules in Subchapters 28A, 28B, 28C, and 28D of this Chapter.

6 (b) As used in the rules in Subchapters 28A, 28B, 28C, and 28D of this Chapter, the following terms have the
7 meanings specified:

8 (1) "Abuse" means the infliction of physical or mental pain or injury by other than accidental means;
9 or unreasonable confinement; or the deprivation by an employee of services **which that** are
10 necessary to the mental and physical health of the client. Temporary discomfort that is part of an
11 approved and documented treatment plan or use of a documented emergency procedure shall not
12 be considered abuse.

13 (2) "Associate Professional (AP)" within the mental health, developmental disabilities and substance
14 abuse services (mh/dd/sas) system of care means an individual who is **either** a:

15 (A) graduate of a college or university with a Masters degree in a human service field with
16 less than one year of full-time, post-graduate degree accumulated mh/dd/sa experience
17 with the population served, or a substance abuse professional with less than one year of
18 full-time, post-graduate degree accumulated supervised experience in alcoholism and
19 drug abuse counseling. Upon hiring, an individualized supervision plan shall be
20 developed and supervision shall be provided by a qualified professional with the
21 population served until the individual meets one year of experience; **or**

22 (B) graduate of a college or university with a bachelor's degree in a human service field with
23 less than two years of full-time, post-accumulated mh/dd/sa experience with the
24 population served, or a substance abuse professional with less than two years of full-time,
25 post-bachelor's degree accumulated supervised experience in alcoholism and drug abuse
26 counseling. Upon hiring, an individualized supervision plan shall be developed and
27 reviewed annually. Supervision shall be provided by a qualified professional with the
28 population served until the individual meets two years of experience; **or**

29 (C) graduate of a college or university with a bachelor's degree in a field other than human
30 services with less than four years of full-time, post bachelor's degree accumulated
31 mh/dd/sa experience with the population served, or a substance abuse professional with
32 less than four years of full-time, post-bachelor's degree accumulated supervised
33 experience in alcoholism and drug abuse counseling. Upon hiring, an individualized
34 supervision plan shall be developed and reviewed annually. Supervision shall be provided
35 by a qualified professional with the population served until the individual meets four
36 years of experience; or

- 1 (D) registered nurse who is licensed to practice in the State of North Carolina by the North
- 2 Carolina Board of Nursing with less than four years of full-time accumulated experience
- 3 in mh/dd/sa with the population served. Upon hiring, an individualized supervision plan
- 4 shall be developed and reviewed annually. Supervision shall be provided by a qualified
- 5 professional with the population served until the individual meets four years of
- 6 experience.
- 7 (3) "Basic necessities" mean the essential items or substances needed to support life and health which
- 8 include, but are not limited to, a nutritionally sound diet balanced during three meals per day,
- 9 access to water and bathroom facilities at frequent intervals, seasonable clothing, medications to
- 10 control seizures, diabetes and other like physical health conditions, and frequent access to social
- 11 contacts.
- 12 (4) "Certified clinical supervisor (CCS)" means an individual who is certified as such by the North
- 13 Carolina Substance Abuse Professional Certification Board.
- 14 (5) "Certified substance abuse counselor (CSAC)" means an individual who is certified as such by the
- 15 North Carolina Substance Abuse Professional Certification Board.
- 16 (6) "Client record" means any record made of confidential information. information as defined in G.S.
- 17 122C-3.
- 18 (7) "Clinical Director" means Medical Director, Director of Medical Services or such person acting in
- 19 the position of Clinical Director, or his designee.
- 20 (8) "Clinically competent" means authorization by the State Facility Director for a qualified
- 21 professional to provide specific treatment/habilitation treatment or habilitation services to clients
- 22 based on the professional's education, training, experience, competence and judgment.
- 23 (9) "Consent" means concurrence by a client or his legally responsible person following receipt of
- 24 information from the qualified professional who will administer the proposed treatment or
- 25 procedure. Informed consent implies that the client or his legally responsible person was provided
- 26 with information concerning proposed treatment, including both benefits and risks, in order to
- 27 make an educated decision with regard to such treatment.
- 28 (10) "Dangerous articles or substances" mean, but are not limited to, any weapon or potential weapon,
- 29 heavy blunt object, sharp objects, potentially harmful chemicals, or drugs of any sort, including
- 30 alcohol.
- 31 (11) "Division Director" means the Director of the Division of Mental Health, Developmental
- 32 Disabilities and Substance Abuse Services or his designee.
- 33 (12) "Emergency" means a situation in a state facility in which a client is in imminent danger of
- 34 causing abuse or injury to self or others, or when substantial property damage is occurring as a
- 35 result of unexpected and severe forms of inappropriate behavior, and rapid intervention by the
- 36 staff is needed. [See Subparagraph (b)(25) of this Rule for definition of medical emergency].

- 1 (13) "Emergency surgery" means an operation or surgery performed in a medical emergency [as
 2 emergency, as defined in Subparagraph (b)(25) of this Rule] Rule, where informed consent cannot
 3 be obtained from an authorized person, as specified in G.S. 90-21.13, because the delay would
 4 seriously worsen the physical condition or endanger the life of the client.
- 5 (14) "Exclusionary time-out" means the removal of a client to a separate area or room from which exit
 6 is not barred for the purpose of modifying behavior.
- 7 (15) "Exploitation" means the use of a client or her/his his or her resources resources, including
 8 borrowing, taking or using personal property with or without her/his his or her permission for
 9 another person's profit, business or advantage.
- 10 (16) "Forensic Division" means the unit at Dorothea Dix Central Regional Hospital which serves
 11 clients who are:
- 12 (A) admitted for the purpose of evaluation for capacity to proceed to trial;
- 13 (B) found not guilty by reason of insanity;
- 14 (C) determined incapable of proceeding to trial; or
- 15 (D) deemed to require a more secure environment to protect the health, safety and welfare of
 16 clients, staff and the general public.
- 17 (17) "Grievance" means a verbal or written complaint by or on behalf of a client concerning a situation
 18 that occurred within the jurisdiction of the state facility. A grievance does not include complaints
 19 that can be resolved without delay by staff present. A complaint that is not resolved shall be filed
 20 and processed in accordance with the requirements of 10A NCAC 28B .0203.
- 21 (18) "Human Rights Committee" means a committee, appointed by the Secretary, to act in a capacity
 22 regarding the protection of client rights.
- 23 (19) "Independent psychiatric consultant" means a licensed psychiatrist not on the staff of the state
 24 facility in which the client is being treated. The psychiatrist may be in private practice, or be
 25 employed by another state facility, or be employed by a facility other than a state facility as
 26 defined in G.S. 122C-3(14).
- 27 (20) "Interpreter services" means specialized communication services provided for the hearing
 28 impaired by interpreters certified by the National Registry of Interpreters for the Deaf or the
 29 National Association of the Deaf.
- 30 (21) "Involuntary client" means a person admitted to any regional psychiatric hospital or alcoholic
 31 rehabilitation center under the provisions of Article 5, Parts 7, 8 or 9 of G.S. 122C and includes
 32 includes, but it is not limited to to, clients detained pending a district court hearing and clients
 33 involuntarily committed after a district court hearing. This term shall also include individuals who
 34 are defendants in criminal actions and are being evaluated in a state facility for mental
 35 responsibility or mental competency as a part of such criminal proceedings as specified in G.S.
 36 15A-1002 15A-1002, unless a valid order providing otherwise is issued from a court of competent

jurisdiction jurisdiction, and the civil commitment of defendants found not guilty by reason of insanity as specified in G.S. 15A-1321.

(22) "Isolation time-out" means the removal of a client to a separate room from which exit is barred but which that is not locked and where there is continuous direct, uninterrupted supervision by staff for the purpose of modifying behavior.

(23) "Licensed professional counselor (LPC)" means a counselor who is licensed as such by the North Carolina Board of Licensed Professional Counselors.

(24) "Major physical injury" means damage caused to the body resulting in profuse bleeding or contusion of tissues; fracture of a bone; damage to internal organs; loss of consciousness; loss of normal neurological function (inability to move or coordinate movement); or any other painful condition caused by such injury.

(25) "Medical emergency" means a situation where the client is unconscious, ill, or injured, and the reasonably apparent circumstances require prompt immediate decisions and actions in medical or other health care, care related decisions and actions to prevent the worsening of the necessity of immediate health care treatment is so reasonably apparent that any delay in the rendering of the treatment would seriously worsen the physical condition condition, or endanger the life life, of the client.

(26) "Minimal risk research" means that the risks of harm anticipated in the proposed research are not greater, considering probability and magnitude, than those ordinarily encountered in daily life or during the performance of routine physical or psychological examinations or tests.

(27) "Minor client" means a person under 18 years of age

(A) who has not been married; married or who

(B) has not been emancipated by a decree issued by a court of competent jurisdiction jurisdiction; or

(C) is not a member of the armed forces.

(28) "Neglect" means the failure to provide care or services necessary to maintain the mental and physical health of the client.

(29) "Normalization" means the principle of helping the client to obtain an existence as close to normal as possible, taking into consideration the client's disabilities and potential, by making available to him patterns and conditions of everyday life that are as close as possible to the norms and patterns of the mainstream of society.

(30) "Paraprofessional" within the mh/dd/sa system of care means an individual who, with the exception of staff providing respite services or personal care services, has a GED or high school diploma; an individual or no GED or high school diploma, employed prior to November 1, 2001 to provide a mh/dd/sa service. service is not required to have a GED or high school diploma. Upon hiring, an individualized supervision plan shall be developed and supervision shall be provided by a qualified professional or associate professional with the population served.

- 1 (31) "Person standing in loco parentis" means one who has put himself in the place of a lawful parent
2 by assuming the rights and obligations of a parent without formal adoption.
- 3 (32) "Physical Restraint" means the application or use of any manual method of restraint that restricts
4 freedom of movement, or the application or use of any physical or mechanical device that restricts
5 freedom of movement or normal access to one's body, including material or equipment attached or
6 adjacent to the client's body that he or she cannot easily remove. Holding a client in a therapeutic
7 hold or any other manner that restricts his or her movement constitutes manual restraint for that
8 client. Mechanical devices may restrain a client to a bed or chair, or may be used as ambulatory
9 restraints. Examples of mechanical devices include cuffs, ankle straps, sheets or restraining shirts,
10 arm splints, mittens and helmets. Excluded from this definition of physical restraint are physical
11 guidance, gentle physical prompting techniques, escorting and therapeutic holds used solely for
12 the purpose of escorting a client who is walking, soft ties used solely to prevent a medically ill
13 client from removing intravenous tubes, indwelling catheters, cardiac monitor electrodes or similar
14 medical devices, and prosthetic devices or assistive technology which are designed and used to
15 increase client adaptive skills. Escorting means the temporary touching or holding of the hand,
16 wrist, arm, shoulder or back for the purpose of inducing a client to walk to a safe location.
- 17 (33) "Protective devices" means an intervention ~~which that~~ provides support for weak and feeble
18 clients or enhances the safety of behaviorally disordered clients. Such devices may include posey
19 vests, geri-chairs or table top chairs to provide support and safety for clients with physical
20 handicaps; devices such as helmets and mittens for self-injurious behaviors; or devices such as
21 soft ties used to prevent medically ill clients from removing intravenous tubes, indwelling
22 catheters, cardiac monitor electrodes or similar medical devices. As provided in Rule .0207 of
23 Subchapter 28D, the use of a protective device for behavioral control shall comply with the
24 requirements specified in Rule .0203 of Subchapter 28D.
- 25 (34) "Psychotropic medication" means medication with the primary function of treating mental illness,
26 personality or behavior disorders. It includes, but is not limited to, antipsychotics, antidepressants,
27 antianxiety agents and mood stabilizers.
- 28 (35) "Qualified professional" means, within the mh/dd/sas system of care, an individual who ~~is~~ is
29 either:
- 30 (A) an individual who holds a license, provisional license, certificate, registration or permit
31 issued by the governing board regulating a human service profession, except a registered
32 nurse who is licensed to practice in the State of North Carolina by the North Carolina
33 Board of Nursing who also has four years of full-time accumulated experience in
34 mh/dd/sa with the population served; ~~or~~ or
- 35 (B) a graduate of a college or university with a Masters degree in a human service field and
36 has one year of full-time, pre- or post-graduate degree accumulated supervised mh/dd/sa
37 experience with the population served, or a substance abuse professional who has one-

- 1 year of full-time, pre- or post-graduate degree accumulated supervised experience in
- 2 alcoholism and drug abuse counseling; ~~or~~
- 3 (C) a graduate of a college or university with a bachelor's degree in a human service field and
- 4 has two years of full-time, pre- or post-bachelor's degree accumulated supervised
- 5 mh/dd/sa experience with the population served, or a substance abuse professional who
- 6 has two years of full-time, pre- or post-bachelor's degree accumulated supervised
- 7 experience in alcoholism and drug abuse counseling; or
- 8 (D) a graduate of a college or university with a bachelor's degree in a field other than human
- 9 services and has four years of full-time, pre- or post-bachelor's degree accumulated
- 10 mh/dd/sa experience with the population served, or a substance abuse professional who
- 11 has four years of full-time, pre- or post-bachelor's degree accumulated supervised
- 12 experience in alcoholism and drug abuse counseling.
- 13 (36) "Regional alcohol and drug abuse treatment center" means a state facility for substance abusers as
- 14 specified in G.S. 122C-181(a)(3).
- 15 (37) "Regional mental retardation developmental disability center" means a state facility for the
- 16 mentally retarded developmentally disabled as specified in G.S. 122C-181(a)(2).
- 17 (38) "Regional psychiatric hospital" means a state facility for the mentally ill as specified in G.S.
- 18 122C-181(a)(1).
- 19 (39) "Representative payee" means the person, group, or facility designated by a funding source, such
- 20 as Supplemental Security Income (SSI), to receive and handle funds according to the guidelines of
- 21 the source on behalf of a client.
- 22 (40) "Research" means inquiry involving a trial or special observation made under conditions
- 23 determined by the investigator to confirm or disprove an hypothesis or to explicate some principle
- 24 or effect.
- 25 (41) "Respite client" means a client admitted to a mental retardation developmental disability center for
- 26 a short-term period, normally not to exceed 30 days. The primary purpose of such admission is to
- 27 provide a temporary interval of rest or relief for the client's regular caretaker.
- 28 (42) "Responsible professional" shall have the meaning as specified in G.S. ~~122C-3~~ 122C-3; ~~except~~ the
- 29 "responsible professional" shall also be a qualified professional as defined in Subparagraph (b)(35)
- 30 of this Rule.
- 31 (43) "Seclusion" means isolating a client in a separate locked room for the purpose of controlling a
- 32 client's behavior. In the Forensic Service, Pretrial Evaluation Unit and the Forensic Treatment
- 33 Program Maximum Security Ward in the ~~Spruill Building at Dorothea Dix~~ Central Regional
- 34 Hospital, the use of locked rooms is not considered seclusion for clients with criminal charges
- 35 who are:
- 36 (A) undergoing pretrial evaluations ordered by a criminal court;
- 37 (B) in treatment for restoration of capacity to proceed;

(C) in treatment to reduce violence risk; or

(D) considered to be an escape risk.

(44) "State Facility Director" means the chief administrative officer or manager of a state facility or his designee.

(45) "Strike" means, but is not limited to, hitting, kicking, slapping or beating whether done with a part of one's body or with an object.

(46) "Timeout" means the removal of a client from other clients to another space within the same activity area for the purpose of modifying behavior.

(47) "Treatment" means the act, method, or manner of habilitating or rehabilitating, caring for or managing a client's physical or mental problems.

(48) "Treatment plan" means a written individual plan of treatment or habilitation for each client to be undertaken by the treatment team and includes any documentation of restriction of client's rights.

(49) "Treatment team" means an interdisciplinary group of qualified professionals sufficient in number and variety by discipline to adequately assess and address the identified needs of the client.

(50) "Unit" means an integral component of a state facility distinctly established for the delivery of one or more elements of service to which specific staff and space are assigned, and for which responsibility has been assigned to a director, supervisor, administrator, or manager.

(51) "Voluntary client" means a person admitted to a state facility under the provisions of Article 5, Parts 2, 3, 4 or 5 of G.S. 122C.
