Re: Objection to Rule 12 NCAC 09E .0105

Dear Ms. Williams:

At its meeting yesterday, the Rules Review Commission objected to the above-captioned rule in accordance with G.S. 150B-21.10.

The Commission objected to Rule 12 NCAC 09E .0105 for failure to comply with the APA and ambiguity. Specifically, at lines 7-13, the agency incorporates a manual of approved training topics by reference, including subsequent amendments and editions. The Rule refers to the manual again at lines 29-31. The list of training topics meets the definition of a "rule" in G.S. 150B-2(8a). Incorporating or referring to the manual rather than stating its contents in the Rule circumvents the permanent rulemaking process set forth in G.S. 150B-21.2. Additionally, the language at lines 29-31 makes it unclear which trainings are required and which trainings are optional.

Please respond to this letter in accordance with the provisions of G.S. 150B-21.12. If you have any questions regarding the Commission's actions, please let me know.

COMMENT:

Staff recommends objection for failure to comply with the APA. At lines 7-13, the agency incorporates a manual of approved training topics by reference, including subsequent amendments and editions. The Rule refers to the manual again at lines 29-31. Incorporating or referring to the manual rather than stating its contents in the Rule circumvents the permanent rulemaking process set forth in G.S. 150B-21.2. The list of training topics meets the definition of a "rule" in G.S. 150B-2(8a) and the list is proposed to be deleted at lines 14-27. As written, this Rule would allow the agency to amend the manual outside the rulemaking process, changing the substance of this Rule without public notice, comment, or RRC review.

Therefore, staff recommends objection to the language in lines 7-13 and 29-31 for failure to comply with the APA.

- 12 NCAC 09E .0105 is amended as published in 34:06 NCR 486-489 as follows:
- 3 12 NCAC 09E .0105 MINIMUM TRAINING SPECIFICATIONS: ANNUAL IN-SERVICE TRAINING 4 (EFFECTIVE JANUARY 1, 2020) 5 (a) The following topics, specifications, and hours shall be included in each law enforcement officer's annual in-6 service training courses. For the purposes of this Subchapter, a credit shall be equal to one hour of traditional classroom 7 instruction. All sworn law enforcement officers shall complete a minimum of 24 in-service training credits. Specific 8 topics identified in the Annual In-Service Manual and approved by the North Carolina Criminal Justice Education and 9 Training Standards Commission shall be as published by the North Carolina Department of Justice, Incorporated 10 herein by reference, and shall include any later amendments and editions of the incorporated materials as provided by 11 G.S. 150B-21.6. The publication shall be available from the Commission's website at https://ncdoj.gov/About-12 DOJ/Law-Enforcement-Training-and-Standards/Criminal-Justice-Education-and-Training-Standards/Forms-and-Publications.aspx. The following topics, totaling 18 credits, shall be specifically required: 13 14 2020 Firearms Training and Qualification (4 credits); (1)15 (2)2020 Legal Update (4 credits); (3)2020 Long Term Effects of Childhood Adversity (2 credits); 16 2020 The Signs Within: Suicide Prevention Education and Awareness (2 credits); 17 (4)18 (5)2020 Career Survival: Training and Standards Issues (2 credits); 19 2020 Communication Strategies When Encountering Persons Who are Deaf or Hard of Hearing (2 (6)20 credits); 21 2020 Armed/Unarmed Security/Company Police: Understanding Their Roles and Authority (2 (7)22 credits); 23 (8)Topics of Choice (12 credits); (A) Hazardous Materials (2 credits); 24 Bloodborne Pathogens (2 credits); 25 (B) -Situational Awareness/Subject Control (4 credits); and 26 (C)Law enforcement Threat Assessment (4 credits). 27 (\mathbf{D}) 28 (b) All sworn law enforcement officers shall complete a minimum of 6 in service credits, in topics identified by their 29 respective agency heads. It is possible for a training topic other than the specific topics identified in the Annual In-30 Service Training Manual to qualify for credit towards officers' Annual In-Service Training requirement. A Department Head The agency head may choose any topic, provided the lesson plan is written in Instructional Systems 31 32 Design format and is taught by an instructor who is certified by the Commission. Topics delivered pursuant to Rule 33 .0104(1) of this Section and National Certification Programs administered by the International Association of 34 Directors of Law Enforcement Standards and Training (IADLEST) completed during the mandated in-service year, 35 shall satisfy in part or in whole the topic requirements set forth by the agency department head. To satisfy this 36 requirement these topics shall not be required to be written in Instructional Systems Design format or delivered by an 37 instructor certified by the Commission.

23	(e) Lesson plans are designed to be delivered in hourly increments. A student who completes an online in-service		
24	training topic shall receive the number of credits that correspond to the number of hours of traditional classroom		
25	training, regardless of the amount of time the student spends completing the course.		
26	(f) Completion	of training shall be demonstrated by passing a written test for each in-service training topic, as follows:	
27	(1)	A written test comprised of at least five questions per credit shall be developed by the agency or the	
28		North Carolina Justice Academy for each in-service training topic requiring testing. Written courses	
29		that are more than four credits in length shall include a written test comprising of a minimum of 20	
30		questions. The Firearms Training and Qualifications in-service course and topics delivered pursuant	
31		to Rule .0104(1) of this Section shall be exempt from this written test requirement;	
32	(2)	A student shall pass each test by achieving at least 70 percent correct answers; and	
33	(3)	A student who completes a topic of in-service training in a traditional classroom setting or online	
34		and fails the end of topic exam shall be given one attempt to re-test. If the student fails the exam a	
35		second time, the student shall complete the in-service training topic in a traditional classroom setting
