Re: Periodic Review and Expiration of 04 NCAC 190

The North Carolina Department of Health & Human Services – Division of Aging & Adult Services (“DAAS”) proposes to adopt 21 rules from 04 NCAC 190 pursuant to G.S. 150B-21.3A as part of the periodic rule review process. These rules pertain to the emergency solutions grant program. Pursuant to G.S. 150B-21.3A(c)(3), legal counsel for the Rules Review Commission has notified DAAS that the Administrative Procedure Oversight Committee did not object to the final determination report.

DAAS has started the process to readopt these rules but is kindly requesting the Rules Review Commission to permit the agency until December 31, 2022, to readopt these rules. DAAS is requesting this proposed readoption date as it is expected a fiscal note will be required, the agency will seek a pre-review of the rules and extensive changes are necessary to reflect current practices.
