State funds shall not replace local funds budgeted and 20 available for expenditure for public library operations; Secure aggregate operational funds from local sources which that are at least equal to state State aid; 21 (5) 22 (6) Expend funds as authorized in the budget adopted by the Board of Trustees of a Regional Library, a 23 County, or a Municipality. 34purpose of this Rule, A long range a "long-range plan of service-service" is a plan of at least five35years. Upon request, the library shall submit an assessment of a community's library needs to the State36Library of North Carolina;

3	(12)	Meet the following stipulations when establishing a new library or re-establishing eligibility for the
4		Aid to Public Libraries Fund:
5		(a) meet all requirements of this <u>Section Rule</u> on July 1 of the year prior to the fiscal year that
6		the library plans to receive state State aid;
7		(b) continue to meet all requirements of this <u>Section-Rule</u> from July 1 to June 30 of that year,
8		which shall be known as the demonstration year; <u>"demonstration year";</u> and
9		(c) file a full <u>complete</u> application for state aid <u>State Aid</u> by the June 30 deadline at the close of
10		the demonstration year in order to receive state State aid in the next fiscal year.
