Please either end (a)(1) through (5) with periods or insert an "and" at the end of (a)(5).

End (a)(6) on line 10 with a period.

In (b), line 11, please insert a comma after "check"

On line 12, consider deleting "However" and inserting an "only" before "accepted" Thus: "Personal checks shall only be accepted for ..."

In the History Note, line 19, please separate the serial citations to G.S. 90-652 thusly: "G.S. 90-652(2); 90-652(9);"

Please put the amended effective date at the bottom of the History Note, line 25.
