What is your specific authority for (b)? While I understand that legally speaking this statement may be accurate, this appears to be a legal conclusion for which you don't have authority. If you feel like you need this, do you mean something like "The certificate holder shall continue to be responsible for the delegated services provided to the client."

In (b), delete "as indicated above" and instead say "as set forth in this Rule."
