Explain: On March 10, 2020, the Governor of North Carolina, by issuing Executive Order No. 116, declared a state of emergency to coordinate a response and enact protective measures to help prevent the spread of COVID-19. The COVID-19 is a respiratory disease that can result in serious illness or death. The COVID-19, previously unidentified in humans, spreads easily from person to person. Once an outbreak of the COVID-19 begins, it is difficult to contain. The World Health Organization, the Center for Disease Control and Prevention, and the United States Department of Health and Human Services have declared COVID-19 a public health threat and emergency. On March 12, 2020, the Governor of North Carolina and the NC Department of Health and Human Services recommended high risk persons stay at home, that schools implement plans for distance or e-learning, that employers and employees use teleworking technologies, and that mass gatherings should cancel, postpone, and modify these events or offer online streaming services. On March 14, 2020, the Governor of North Carolina issued Executive Order No. 117 that prohibited mass gatherings, closed schools, and urged social distancing. On April 23, 2020 the Governor extended the effective date on these various Executive Orders through at least May 8, 2020. This rule amendment will extend the continuing education deadline for license renewal since most course offerings would not be in compliance with the Governor's Executive Orders.

TEMPORARY RULES REQUEST FOR TECHNICAL CHANGE

AGENCY: Board of Landscape Architects

RULE CITATION: 21 NCAC 26 .0309

DEADLINE FOR RECEIPT: Wednesday, August 12, 2020

The Rules Review Commission staff has completed its review of this rule prior to the Commission's next meeting. The Commission has not yet reviewed this rule and therefore there has not been a determination as to whether the rule will be approved. You may call this office to inquire concerning the staff recommendation.

In reviewing these rules, the staff determined that the following technical changes need to be made:

In the Temporary Rulemaking Findings of Need form, Box 5(a), please confirm this date, as the OAH online posting says it was submitted on April 29.

In Box (5)(d), this comment period is not the same as the comment period you published on the OAH website. The comment period on your form complies with the APA, so I am only asking – I take it your regulated public knew of the correct dates of the public comment period?

In the Rule:

In (c), line 16, please make "national" lowercase.

Also on line 16, replace "which" with "that"

On line 17, what is "active participation"? Is it the term used in Rule .0307 of this Section? If so, then shouldn't the rest of the language also mirror that rule, and state "active participation in Board approved continuing education"?

And please insert a comma after "education"

On line 17, you state it "may" be extended. Under what circumstances will it not be waived? Do you mean "shall"? Or do you want to use the language from other temporary rules and state "the Board may extend the compliance period if requested by the licensee up to 90 days..."?

On line 19, what do you mean by "conditionally"?

And so that I'm clear – are you expecting to keep the September 30 date in any permanent rule?

On line 20, what is this portal? Does the regulated public know?

Also, please make "online" one word without a hyphen.

3	21 NCAC 26 .03	09 EXEMPTIONS AND EXTENSION OF TIME
4	(a) A registrant s	shall be exempt from the continuing education requirements for any of the following reasons:
5	(1)	New registrants by way of examination or comity for the current registration year.
6	(2)	A licensee serving on temporary active duty in the armed forces of the United States for a period of
7		time exceeding 90 consecutive days in a year or as provided by G.S. 93B-15(b), whichever is greater.
8	(3)	A licensee experiencing physical disability or illness if supporting documentation is approved by
9		the Board. Such documentation shall be in the form of a sworn statement by the registrant, a
10		statement from a physician, or medical records which show that the disability or illness, prevented
11		registrant's participation in a course that the registrant had enrolled, or prevented registrant's
12		participation in the continuing education program for at least 90 consecutive days in a year.
13	(4)	A licensee with emeritus status from the Board.
14	(b) In order to	return to active practice, registrants who have received an exemption shall complete continuing
15	education require	ements for each exempted year, not to exceed two years.
16	(c) During a Na	ational or State declared state of emergency which restricts or prohibits a licensee from obtaining by
17	active participation	on approved Board continuing education the Board may extend the compliance period up to 90 days
18	beyond the effec	tive period of the state of emergency. Any license renewed in reliance on this exemption shall be
19	issued conditiona	ally and shall automatically expire on September 30, 2020 or on the 90th day, whichever is later, if
20	compliance is no	t documented in the licensee's secure on-line portal by that date.
