If so, one solution is to delete the reference to (b) here, and in (b) say "In addition to the requirements set forth in Paragraph (a) of this Rule, all students shall be trained on the following performance requirements" (or whatever the actual requirement is.)

Please be consistent in your capitalization in (a)(1) through (33). Specifically, (a)(30) and (31) are lower-case. The rest are capitalized.

In (a)(2), why have you changed "sanitation", which is the statutory term, to "infection control"?

Please move the "and" at the end of (a)(31) to (a)(32)

In (a)(33), change "regulations" to "Rules."

Please review and revise (b) for clarity. As written, it's not clear what the actual requirement is. Also, with the deletion of the hours required, is the amount of time spent on each performance up to the schools? Perhaps it would be more clear to delete your current (b) and move and combine (g) and (b). I think that (g) adds some clarity to the intent here.

Why was (b)(33) added after publication? Is this an entirely new requirement? I'm concerned about a substantial change here if your regulated public was unaware that they were required to address this topic.

If you keep "lash lifting", end it with a period and add "and" after (b)(32).

In (g), add an "s" to "evaluation plan" on line 13.

In (g), change "section b" to "Paragraph (b)" of this Rule. If you combine (b) and (g), you may end up deleting this.

In (d), why are you changing "sanitation" to "infection control"? "Sanitation" is the statutory term.

In (d), change "regulations" to "rules"

Also in (d), 14H has more than just Infection Control Rules, do you mean .0403?

In (f), what is meant by "as a minimum"? Do the schools have the option of using some other number? I don't understand how "a minimum" would be applicable here.

Please consider writing (g) to be in the positive. Perhaps something like "in order to graduate, all students shall meet the minimum school and Board requirements as set forth in Rules .0602 - .0610 of this Subchapter."

In (i), does the cosmetic art teacher required to be in the room at the time of the guest lecturer have to be affiliated with the school (either by employment or under contract)?

In (j)(3), should the "or" at the end of line 29 be something like "as follows"? I don't understand "or" here.

In (k), is there a maximum?

How do (k) and (l) go together? They appear to have the potential to conflict. Please review and clarify. Also, note that you've hyphenated "teacher-student" in (k), but not in (l). Please be consistent.

- 6 (a) No individual shall be given credit for any hours earned in a cosmetic art school before the date the school is
