All of the text from line 5-16 should have been underlined; however, abide by 26 NCAC 02C .0405(b)(1) in rewriting the Rule in response to these tech change requests.

Line 1 – the introduction should be in the following format:

13 NCAC 15 .0208 is adopted as published in XX:XX NCR XXXX as follows:

Line 5 – add a comma after “maintenance”

Lines 7, 10-11, and 12 – replace “the A17.18-2016 –“ with “Standard A17.18-2016 of the”

Line 7 – delete “which is hereby”

Line 8 – replace “reference. This incorporation includes” with “with”

Lines 8-9 – delete “of this Code”

Line 10 – replace “when” with “if”

Line 13 – delete the comma

Line 19 – add the effective date

3 **13 NCAC 15 .0208 SAFETY STANDARDS FOR WIND TURBINE TOWER**

4 **ELEVATORS**

5 (a) The design, construction, installation, alteration, repair, replacement, inspection, maintenance
6 and operation of all installations of wind turbine elevators shall conform to the rules in this
7 Section and the A17.8-2016 - American Society of Mechanical Engineers, which is hereby
8 incorporated by reference. This incorporation includes subsequent amendments and editions of
9 this Code.

10 (b) The rules of this Chapter shall control when any conflict exists between these rules and the
11 A17.8-2016 - American Society of Mechanical Engineers.

12 (c) Copies of the A17.8-2016 - American Society of Mechanical Engineers are available for
