However, most don't perform in-house air monitoring services thus the increase in small firms specializing in air monitoring services as there main revenue generator. Yet not enough to sustain the expense of retaining a SAM (CIH or PE). This causes each to subcontractor their SAM services, which are limited throughout the year. Those who perform the SAM services for such firms typically are competitors therefore guidance or evaluation for work performance is limited at best.
