


9B. Explain: The N.C. State Fair sought an increase in admission prices beginning with the 2013 State Fair. S.L. 2013-360 section 13.6 granted the Board of Agriculture a one-time waiver of the rules to enact a fee increase. We are now seeking to make permanent this fee increase by codifying these changes into the Administrative Code. The State Fair, being an enterprise fund, relies on revenues from the State Fair and year round events to fund all expenses. The proposed increases will help maintain the necessary monies to meet these expenses. In addition, the rules clarify the different hours of operation during the fair.

9B. Explain: The proposed increase in waste analysis fees will offset budget cuts generated by the managerial flexibility cuts mandated by the General Assembly in S.L. 2013-360. As seen on page H1 of the Conference Report on the Continuation, Capital and Expansion Budget, the Department was directed, under Management Flexibility Reserve, to reduce funds by 1.5% or \$1.5 million. The increase in the waste analysis fee offset this reduction in funding. The other fees listed have been a part of the fee scheduled adopted in 2005, but are added here to make the rule as up to date and accurate as possible. This rule became temporary on December 3, 2013 so the division could begin collecting the updated fee and we are now making this change permanent.



Explain: 07 NCAC Subchapter 04M applies to the Division of Archives and Records (Division) in the Department of Cultural Resources (DCR), previously identified at the Archives and Records Section. Specific explanations for rule repeals include: Rule 04M .0101 - A statement of purpose for the Division is not necessary for Administrative Code. Rule 04M .0102 - Listing the public hours for Division programs is not necessary for Administrative Code. Rule 04M .0103 - Information on services and research is available on the Division website and not in printed circulars. Rule 04M .0205 - The rule text is incorporated in the amended text for rule 04M .0204. Rule 04M .0302 - It is a conflict of interest for the Division to assign a value to a collection it is accepting as a donation. Staff is not qualified to assign value to collections nor to arrange for the valuation of potential gifts. Donors have always been responsible for any financial burden in seeking a valuation of gifts. Currently staff will refer donors to generic resources on locating a qualified appraiser, but we do not recommend particular companies or individuals. Deletion of this section will not result in any additional staff time, nor will it result in additional financial or time burdens for a donating individual. Rule 04M .0303 - The rule text is incorporated in the amended text for rule 04M .0301. Rule 04M .0505 - Agency legal counsel advised that this section was duplicative of rule 04M .0502. 07 NCAC Subchapter 04V applies to one facility managed by the Division. All provisions of Subchapter 4V are covered in Subchapter 4M. There is no need for an entire portion of the Administrative code to be devoted to one facility managed by the Division when all rules governing use of the facility and collections are included in Subchapter 4M. Rule 04V .0202 concerning rules for use of the gallery were moved to Subchapter 04M .0107. The rest of subchapter 04V rule text is subsumed in the amendments in subchapter 4M.





9B. Explain: 07 NCAC Subchapter 04M applies to the Division of Archives and Records (Division) in the Department of Cultural Resources (DCR), previously identified at the Archives and Records Section. The entire subchapter was examined for moderate edits, including those reflecting the change in organizational structure within DCR that elevated the Archives and Records program to a division. Additional minor edits were suggested by agency legal counsel, including the use of the word "shall" in place of "will." Regulations governing research facilities have been updated to account for procedures in all Division facilities. Language was made generic where possible to account for any variations in procedures for handling records. Identification requirements have been and continue to be the same across the Division. Additional language regarding use of equipment deemed to be acceptable for use with original records was added to accommodate requests by patrons for regulations governing use of imaging equipment in the Search Room. Language was made generic where possible to account for changes in technology while still allowing the Division to prevent equipment that would harm original records from being used by patrons.



Explain: 07 NCAC Subchapter 04M applies to the Division of Archives and Records (Division) in the Department of Cultural Resources (DCR), previously identified at the Archives and Records Section. The entire subchapter was examined for moderate edits, including those reflecting the change in organizational structure within DCR that elevated the Archives and Records program to a division. Additional minor edits were suggested by agency legal counsel. The rule has been amended to reflect currently available duplication services. Deleted services are no longer available due to inability to maintain equipment or purchase supplies, such as photographic prints from negatives. All duplication services are digital now. In addition, the Division no longer has any requests for typed certified copies. Also, DCR added a statutory reference to the history note.

9B. Explain: The Board's authority to charge fees is found in NCGS 143-151.57(a). Typically, the Board reviews and approves continuing education courses submitted by approved sponsors. However, if a licensee chooses to take an unapproved continuing education course, N.C.G.S. 143-151.64(c) allows the Board to charge a fee to the licensee for each unapproved course submitted to the Board for continuing education credit. The establishment of the unapproved continuing education course fee is necessary due to the increased time needed to evaluate an unapproved continuing education course. All course documentation of unapproved courses must be evaluated by the Education Coordinator on a case-by-case basis to determine whether credit for taking the course should be given to the licensee. The Board is specifically authorized by N.C.G.S. 143-151.57(a) to charge \$50.00 per submission of each unapproved continuing education course. The Board is seeking to specify the fee charged for a course that has not been previously approved by the Board and that is not subject to the approved sponsor payment of the \$5.00 per hour student fee set out in Board rule 11 NCAC 08.1332 and authorized by N.C.G.S. 143-151.57(a). The \$50.00 fee for the unapproved course is in lieu of the \$150.00 fee paid by sponsors when applying for course approval pursuant to 11 NCAC 08.1319, and the \$75.00 fee paid by sponsors when applying for renewal of course approval, pursuant to 11 NCAC 08.1336. These sponsor fees are set out in 11 NCAC 08.1011 and authorized by N.C.G.S. 143-151.57.
