The first proposed change is an amendment to Subsection (3). This is to clarify a long-standing interpretation of the existing rules. That is, in order to be included on the large wrecker rotation list, the wrecker company must have at least one large wrecker located within the county and designated for the sole use in that county. In order to be included on the small wrecker rotation list, the wrecker company must have at least one small wrecker located within the zone and designated for the sole use in that zone. This is the standard that has been imposed for many years and wrecker services across the state have been in compliance with standard, which serves the purpose of insuring the wrecker can respond in a timely manner. Recently, however, the Patrol's interpretation of the rule was challenged in the Office of Administrative Hearings and the law judge found that the rule was not as clear as we believed. This amendment clarifies any ambiguity in the rule and large wreckers will need to be stored within the county; small wreckers will need to be stored within the wrecker zone. The rationale for the rule is to allow for a timely response to a call for service.

The second proposed change is an amendment to Subsection (14). Wrecker service owners may not use drivers who have certain criminal convictions or who fail to meet certain other safety standards. One of the wrecker owners was allowing a convicted felon ride-along on Highway Patrol rotation calls. The Patrol could not prohibit this practice because the rules, as they now exist, apply only to drivers, not passengers. Accordingly a driver may allow a convicted sex offender or other dangerous criminal to accompany him or her while transporting a stranded driver. One of the two proposed amendments is designed to address this issue.

Since their supervisory appraiser must either have a North Carolina appraiser credential or obtain a temporary practice permit, it is expensive as well as unduly burdensome on the trainee to have to obtain a separate temporary practice permit. Paragraph (o) would prohibit a broker who is selling property in which the broker has an ownership interest from representing a buyer of the property, except that a firm listing a property owned by a broker affiliated with the firm may represent a buyer of that property so long as the individual broker representing the buyer does not have an ownership interest in the property and the buyer consents to the representation after full disclosure. Paragraph (p) would prohibit a listing broker or firm from purchasing the listed property unless the broker or firm first discloses to their principal in writing that a potential conflict of interest exists and that the principal may want to seek independent counsel.
