The Commission has not yet reviewed this rule and therefore there has not been a determination as to whether the rule will be approved. In reviewing these rules, the staff determined that the following technical changes need to be made:

- In (3), does your regulated public know what you mean by "a system of control and accountability?"
 - In (5), delete or define "suitable" before "safety-closure containers."
- In (6), what is considered a "suitable" record? Is there another rule that provides additional information as to what will be considered "suitable" for purposes of the maintenance of records?

Item (7) is a bit unclear given that most of the Items appear to be limitations set for the nurse? Is the intent that the pharmacist-manager is responsible for ensuring compliance with all Items?

Please retype the rule accordingly and resubmit it to our office at 1711 New Hope Church Road, Raleigh, North Carolina 27609.

4	A registered nurse employed by a local health department may dispense prescription drugs or devices under

6	(1)	Drugs or devices may be dispensed only to health department patients; patients, with the
7		exception of opioid antagonists, which may be dispensed either to health department
8		patients or to others as permitted by G.S. 90-106.2:
9	(2)	No drugs or devices may by dispensed except at health department clinics;
10	(3)	The health department shall secure the services of a pharmacist-manager who shall be
11		responsible for developing and supervising a system of control and accountability of all
12		drugs dispensed from the health department;
13	(4)	Only the general categories of drugs or devices listed in Rule .2403 may be dispensed by
14		a health department registered nurse;
15	(5)	All drugs or devices dispensed pursuant to G.S. 90-85.34A and these rules shall be
16		packaged in suitable safety-closure containers, where appropriate, and shall be properly
17		labelled (including necessary auxiliary labels) so as to provide information necessary for
18		use and all other information required by state and federal law;
19	(6)	A suitable and perpetual record of drugs or devices dispensed shall be maintained in the
20		health department. The pharmacist-manager shall verify the accuracy of the records at
21		least weekly, and where health department personnel dispense to 30 or more patients in a
22		24-hour period per dispensing site, the pharmacist-manager shall verify the accuracy of
23		the records within 24 hours after dispensing occurs;
24	(7)	The duties of the pharmacist-manager set out in Paragraphs (1) through (6) in this Rule
25		may be delegated to a pharmacist licensed by the Board. The pharmacist-manager shall
26		remain personally responsible for compliance with all statutes, rules, and regulations
27		governing the practice of pharmacy and dispensing of drugs.

4	(a) Pursuant t	to the provisions of G.S. 90-85.34A(a)(3), prescription drugs and devices included in the
5	following gene	ral categories may be dispensed by registered nurses in local health department clinics when
6	prescribed for the indicated conditions:	
7	(1)	Anti-tuberculosis drugs, as defined by the latest edition of Drug Facts and Comparisons,
8		as published by Facts and Comparison Div., J.B. Lippincott Co., or as recommended by
9		the Tuberculosis Control Branch of the North Carolina Division of Health Services, when
10		used for the treatment and control of tuberculosis;
11	(2)	Anti-infective agents used in the control of sexually-transmitted diseases as
12		recommended by the United States Centers for Disease Control;
13	(3)	Natural or synthetic hormones and contraceptive devices when used for the prevention of
14		pregnancy;
15	(4)	Topical preparations for the treatment of lice, scabies, impetigo, diaper rash, vaginitis,
16		and related skin conditions; and
17	(5)	Vitamin and mineral supplements; and supplements.
18	(6)	Opioid antagonists prescribed pursuant to G.S. 90-106.2.
19	(b) Regardless of the provisions set out in this Rule, no drug defined as a controlled substance by the	
20	United States Controlled Substances Act, 21 U.S. Code 801 through 904, or regulations enacted pursuant to	
21	that Act, 21 CFR 1300 through 1308, or by the North Carolina Controlled Substances Act, G.S. 90-86	
22	through 90-113	.8, may be dispensed by registered nurses pursuant to G.S. 90-85.34A.
