Re: Periodic Review and Expiration of Existing Rules
Title 24, Chapter 2 (Rules 24 NCAC 02A .0101 - .0103, 02B .0101 - .0102, and 02C .0101.)

Dr. Bordeaux:

At the July Rules Review Commission's meeting, it was noted that the Agricultural Finance Authority did not file the existing rules report required by G.S. 150B-21.3A and Rule 26 NCAC 05 .0203(c) for Commission review at its August 21, 2014 meeting.

Pursuant to G.S. 150B-21.3A, all agencies subject to rulemaking under Article 2A of the North Carolina Administrative Procedure Act are required to review all existing rules in the North Carolina Administrative Code. Your agency is subject to rulemaking under Article 2A. The Rules Review Commission was given authority by the General Assembly to set the schedule for each agency to conduct the review. That schedule was adopted by the RRC effective April 1, 2014 and is contained in Rule 26 NCAC 05 .0211.

Your agency is scheduled for review by the Commission at the August 21, 2014 meeting. The deadline for filing the report was July 15, 2014. The agency did not file the report by the deadline. Pursuant to G.S. 21.3A(b), the above-referenced rules will expire on August 21, 2014, and they will be deemed repealed as of that date. As such, the Codifier will remove the rules from the North Carolina Administrative Code.
