Dear Ms. Bakewell:

At its meeting today, the Rules Review Commission objected to Rule 21 NCAC 16D .0106 in accordance with G.S. 150B-21.10. The Commission found that the language was ambiguous as written, as it states the Board will look into any information deemed proper as it relates to the applicants qualifications or character; however, the Rule gives no guidance as to what that will be. Further, the Commission found that the Board does have statutory authority to create a waiver of recovery of damages against the Board, its members or any person who answers a Board inquiry, as proposed in the Rule.

In addition, the Commission extended to period of review pursuant to G.S. 150B-21.10 for Rules 16D .0104, 16E .0103 and .0104. The Commission did this in response to a request by the agency to extend the period of review.

Pursuant to G.S. 150B-21.13, when the Commission extends the period of review, it is required to approve or object to rules or call a public hearing on the same within 70 days.

Please respond to this letter in accordance with the provisions of G.S. 150B-21.12. If you have any questions regarding the Commission's actions, please let me know.
