



Pursuant to S.L. 2014-77, nine rules adopted by the Industrial Commission in 2014 and one rule adopted in 2012 were disapproved by the General Assembly. The session law also contained directives and authority to amend and readopt the disapproved rules. Section 7 of S.L. 2014-77 states that the Industrial Commission "shall adopt permanent rules in accordance with the provisions of this act using the procedure and time lines for temporary rules set forth in G.S. 150B-21.1(a3)." It further states, "Rules adopted pursuant to this section shall not be subject to G.S. 150B-19.1(h) or G.S. 150B-21.4." The Industrial Commission was ordered by the session law to "consult with the Office of Administrative Hearings to ensure rules adopted in accordance with this section are submitted to the Rules Review Commission in time to be eligible for legislative disapproval in the 2015 Regular Session of the 2015 General Assembly." In order to ensure completion of the rules process prior to the beginning of the 2015 Regular Session, the Industrial Commission is submitting these rules to the Rules Review Commission before its October 16, 2014 meeting.
