However, this restriction is made on the CONSULTANT S ONLY. I know of many instances where industry-employed foresters have performed timber estimate, timber trespas s evaluation and other services FOR PRIVATE LANDOWNERS FOR A FEE by \"moonlighting\" from their jobs. I respectful ly as why there is not a rule to prevent salaried, industry-employed foresters from competing with certified consulting foresters for this activities while those industry or government foresters are engaged in timber procurement or government work? It seems that there is no mechanism for this or even a rule to prevent it. If an industry foresters can consult, with impunity, for a fee, why then is a consultant restricted from timber procurement and buying and reselling timber on his own?

The law is not intended to serve the interests of consulting foresters.
